In exercise of the powers conferred vide reference 2nd cited, sanction of the Secretary to the Govt.(Fisheries) is hereby conveyed to incur an expenditure not exceeding to **Rs.10,422/- (Rupees Ten thousand four hundred and twenty two only)** towards grant of 75% subsidy on the annual insurance premium paid by 09 numbers of registered mechanized fishing boat owners of Puducherry region for insuring their boats against marine risks, as detailed in the Annexure for the year 2020-21, under the Scheme "*Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen*" as phase-IV.

2. Permission is also accorded to release an amount of **Rs.10,422/- (Rupees Ten thousand four hundred and twenty two only)** directly to the beneficiaries' savings bank account by way of ECS mode.

The expenditure is debitible to the Head of Account, "*2405-Fisheries-103 (05) - Development of Marine Fisheries through Mechanization and Reimbursement of Sales Tax on HSD oil and Assistance to Small Scale Fishermen – 103 (05) (01) - Puducherry region (33)- Subsidies*" in the Revised Estimate of the current financial year 2020-21.
