NOTIFICATION

The Department of Health & Family Welfare Services, Puducherry in the advertisement No.A.12020/1/2013/E4/DHFWS dated 17.05.2013 have notified 18 vacancies (UR-9, MBC-5, OBC-3, SC-1) for recruitment of the eligible candidates to the post of Senior Laboratory Technician (Group 'C') carrying the Pay Band 2 of Rs.9300-34800 plus Grade Pay of Rs.4200 fixing the last date for receipt of filled in application on 21.06.2013. A deduction of 5% of marks for every additional attempt in the requisite educational qualification(s) shall be made. In addition to the above, 1.5 marks per every completed year of seniority from the date of registration of requisite educational in the Employment Exchange to the last date of receipt of duly filed in application will be added, subject to a maximum of 15 marks. Thus the qualifying marks have been calculated to the maximum total marks of 115 (100+15).
