

The extent of age concession in respect of In-service officials, Widows / Divorced Women / Women Judicially separated and who are not remarried & Meritorious Sports person as notified in this Department's Notification on the subject under reference first cited may be corrected to be read as follows consequent on the issuance of G.O. second cited above.

Category	FOR	READ
Meritorious Sports Person	5 years (in respect of reserved applicants, over and above the admissible relaxation of 5 years for SC and 3 years for MBC/OBC/EBC/BCM/BT)	Upto 5 years (10 years for SC)
Widows / Divorced Women / Women judicially separated from their husbands and who are not re-married.	5 years (in respect of reserved applicants, over and above the admissible relaxation of 5 years for SC and 3 years for BT/BCM/EBC/OBC/MBC).	Up to the age of 35 years (up to 40 years for SC) but no relaxation of educational qualification.
In-service officials	Relaxable for Government servants upto 40 years in accordance with the instructions or orders issued by Central Government provided such Government servants are working for not less than 3 years in posts which are in the same line or allied cadres and where a relationship can be established that the services rendered by them in the Department will be useful for efficient discharge of duties in the post for which selection is made.	Relaxable for Government servants Upto to 40 years of age (45 years for SC) in accordance with the instructions or orders issued by Central Government provided such Government servants are working for not less than 3 years in posts which are in the same line or allied cadres and where a relationship can be established that the services rendered by them in the Department will be useful for efficient discharge of duties in the post for which selection is made.

2. All other conditions of this Department's Notification of even number dated 04.05.2012 remain unaltered except the last for receipt of both generation of online application and also for submitting the same alongwith the attested photocopies of the required testimonials which is extended upto 29.06.2012.
