Two posts of Executive Officer Grade-III (Group "C") carrying the scale of pay Band - 1 of Rs.5200-20,200+G.P. 2800 (in pre-revised) is to be filled up in the office of the Commissioner for Hindu Religious Institutions, Puducherry.

2. The post is to be filled up by transfer on deputation of officers of this administration holding analogous posts (or) with five years of regular service in posts in the scale of pay of Rs.5200 – 20200 + GP 2400 (in pre-revised scale). Candidates possessing Law Degree will be preferred.
3. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding the appointment in the same or some other organization / department of the central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not exceeding 56 years as on the closing date of receipt of application.

All the Heads of Departments/Offices are therefore requested that this may be widely circulated among their staff and forward applications of eligible and willing officials, if any, in the enclosed proforma on or before **23.08.2021** along with their up to date APARs duly verified and certifying that the particulars furnished by the official are correct. Applications received after the last date and without APARs shall not be considered. They are also requested not to send the applications of the officials against whom disciplinary / Vigilance / Criminal case has been initiated /contemplated / pending.
