ORDER

The PMGDISHA -Pradhan Mantri Gramin Digital Saksharta Abhiyan Scheme aims to make six crore persons in rural areas across States/UT digitally literate, reaching to around 40 % of rural households by covering one member from every eligible household in a span of three years upto 31st March 2019 .The scheme is aimed at empowering the citizens in rural areas with 28,000 as target for the Puducherry UT by training them to operate computer / digital access devices enabling them to use the information technology and related applications especially Digital Payments to actively participate in the process of nation building.

2. The above scheme will be implemented by the CSC e-Governance Services India Ltd (CSC-SPV) in active collaboration with the Directorate of Information Technology, District e-Governance society (DeGS) and relevant district-level officials. The State Level Committee is constituted to plan strategies for implementation of the scheme with the following composition and terms of reference as stated in the guidelines for PMGDISHA.

 - The Committee shall meet at least once in two months.

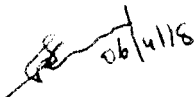
