ORDER

Sanction of the Lieutenant Governor is hereby conveyed to release an amount of **Rs.28.15/- lakhs (Rupees Twenty eight lakhs and fifteen thousand only)** as Grant-in-Aid to the “**Franco Indian Vocational Training Institute Society, Puducherry**” for the year 2011-12 towards the , payment of Faculty fee to the Nodal Agency for conducting course for two Bio Medical Engineering Courses ,Staff salary/Wages and other Administrative Expenses of the society.

2. The Society shall function strictly in accordance with Rules and Regulations of the Franco Indian Vocational Training Institute Society, Puducherry approved by the Government and submit Utilization Certificate for the above said amount as per Rules.

3. The release of Grant-in-Aid is subject to the following conditions:-

- i) The Grant-in-Aid amount should be utilised for the purpose for which it has been sanctioned.
- ii) A certificate of actual utilization of the Grant-in-Aid shall be furnished in accordance with GFR 212(1) in the Form GFR 19-A.
- iii) The unspent balance of the Grant-in-Aid released during the year along with interest accrued on the deposited amount if any, shall be brought forward to the subsequent year as part of the Scheme fund and shall be accounted in the utilization certificate issued in GFR 19-A.
- iv) The Grant-in-Aid shall be utilized in a time bound manner and in any case not later than three months from the closure of the financial year.
- v) The Institution shall get its accounts audited by the Chartered Accountant and the audited statement of financial accounts shall be submitted to Government during the subsequent financial year as required under GFR 212.
- vi) The accounts of the Institution shall be open to inspection by the Sanctioning Authority and audit by the Directorate of Accounts and Treasuries/Accountant General.
- vii) The Institution shall maintain subsidiary accounts for the Grant-in-Aid received from Government as required under GFR 210.
- viii) Annual report of the Institution shall be submitted to the Government duly approved by the Institution's Governing Body.
