**GOVERNMENT OF PUDUCHERRY
CHIEF SECRETARIAT (RURAL DEVELOPMENT)**

ORDER

The Ministry of Rural Development, Government of India has restructured the existing Centrally Sponsored Scheme Swarnajayanti Gram Yojana (SGSY) throughout India as National Rural Livelihood Mission (NRLM).

2. Government of India expects that all States/UTs. would have to transit to NRLM in the current financial year by fulfilling certain pre-conditions such as notifying separate State Rural Livelihood Mission (SRLM) Society and appointing a Mission Director of SRLM. The funding under SGSY is going to stop by 31-12-2011. The funds required for setting up of separate SRLM Society has to be met out from 5% administrative costs admission under SRLM. In the case of Puducherry as per Planning Commission norms, the funding per annum is likely to be insufficient for setting up and running SRLM as a separate society. This point was highlighted in various NRLM preparatory meetings and hence it is proposed by DRDA to notify the existing DRDA to act as "Puducherry State Rural Livelihood Mission Directorate" for implementation of NRLM in Puducherry and Project Director, DRDA would function as Mission Director, Puducherry State Rural Livelihood Mission (PSRLM). As the Union territory of Puducherry being small area comprising of six development blocks only, the existing Governing Body of DRDA would also look after the functions of Governing Body and Executive Committee of SRLM and one member each from NABARD, Ministry of Rural Development, Government of India and Self-help Group Federation would be co-opted in conformity to the suggested norm of Ministry of Rural Development, Government of India.

3. Therefore, the Lieutenant-Governor, Puducherry is pleased to accord for the proposal at paragraph 2 above for notifying the District Rural Development Agency as the 'Puducherry Union Territory Rural Livelihood Mission'.
