At the outset, the Chairman of the Committee, viz. the Secretary, Puducherry Housing Board, Puducherry, invited the Members of the "Lot" Committee and the short-listed applicants falling under the meaning of "Distressed Purchasers", who came to participate in the "Lot", for the allotment of one undeveloped plot, measuring an extent of 1000 sq.ft. @ Rs.720/- , situated at Ward No. "N", Block No.12, T.S. 22/2 and R.S. No.144/2 at Murungapakkam Revenue Village belongs to the Puducherry Housing Board, Puducherry.

Since the copies of the Government Order (G.O.Ms. No.40/2015-Hg. dated 21.12.2015) containing the guidelines and terms & conditions; Proceedings of the Scrutinizing Committee held on 27th & 28th January, 2016; copy of the Sketch showing the Plot numbers from 01 to 106 and the relevant Board's Resolution dt.05.02.2016 have already been perused by the "Lot" Committee Members, the said short-listed 76 applicants falling under the meaning of "Distressed Purchasers", were once again reminded about the salient points prescribed in the Guidelines and Terms & Conditions annexed with the Govt. Order G.O.Ms.No.40/2015-Hg. dt.21.12.2015.

Further, the Board has informed all the Distressed Purchasers that (1) one Mrs.Canniacoumary & 7 others have filed W.P.No.3021/2015 before the Hon'ble High Court, against the Government, Deputy Collector (Land Acquisition) and the Board, challenging the above Land Acquisition Proceedings and (2) one Mr.R.Sathiyamurthy has filed W.P.No.6361/2016 before the Hon'ble High Court, against the Government and the Board, praying to quash the above G.O.Ms.No.40/2015-Hg, Chief Secretariat (Housing), dt.21.12.2015. The said W.Ps. are pending sub-judice before the Hon'ble High Court. Therefore, the "Lot" conducted by the Board is subject to the final orders of the above 2 W.Ps., as no "Interim Injunction has been granted by the Hon'ble High Court as informed by the Board's Counsel. It was also decided by the Lot Committee to issue Provisional Allotment Orders and collect the sale consideration from the allottees.

Thereafter, the "Lot" was conducted for allotment of one undeveloped plot each to the short-listed 76 Distressed Purchasers and all were present. The details of the selection of Plot numbers from 01 to 76 against the short-listed 76 Distressed Purchasers by the "Lot" Committee were as follows :-
