On behalf of the Pondicherry Municipal Council, tenders through e- Tendering are invited by the undersigned from the eligible contractors / firms registered with P.W.D., Puducherry and the contractors not registered with PWD, Puducherry but registered in other state Government / PSU should produce documentary evidence in support of their having satisfactorily three similar completed works costing not less than 40% of estimated cost put to tender or two similar completed works costing not less than 50% of estimated cost put to tender or one similar completed works costing not less than 80% of estimated cost put to tender in the last seven years ending previous day of last date of submission of tenders. (Similar work means execution of Building / Roads/Drain works). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of submission of tenders. The contractor after purchasing the valid key and Digital signature Certificate can only be able to download the Tender Notice, Notice Inviting Tender and other related documents and upload the bid document online by verifying the Tender Number assigned for each work from https://pudutenders.gov.in.

- 2. Tender Form-6 and BOQ can be downloaded and submitted online through the Website https://pudutenders.gov.in only by those contractors, who are having valid key and Digital Signature Certificate. .
- 3. The contractor shall upload modified provisions as per enlistment copy for modified limit, otherwise the tender will be rejected.

4. Eligibility conditions for the Bidder

(a). Condition stipulated for all works

"The Contractors who are having three works or more on hand at the time of tendering are not eligible to participate in the tender" (PWD/ OTHER THAN PWD CONTRACTORS). The participating contractor shall submit the list of works in hand (progress) in Letter pad and to be uploaded along with NIT (FORM-6) in the format (Form-D) given in NIT.

(b). Condition stipulated for road works

(i) For works costing upto Rs.3.00 crores

Contractors should hire/lease the following machineries and should produce original Documentary evidence of Hiring / leasing.

- 1. Central Hot Mix Plant of 40 TPH to 60 TPH capacity with compatible electronic control system 1no.
- 2. Hydrostatic Paver finisher with Sensor control 1no.
- 3. Vibratory Roller -1 no.

(ii) For works costing more than Rs.3.00 crores

Contractors should own the following machineries and should produce original documentary evidence of the ownership. ϵ

- 1. Central Hot Mix Plant of 40 TPH to 60 TPH capacity with compatible electronic control system. 1no.
- 2. Hydrostatic Paver finisher with Sensor control 1no.
- 3. Vibratory Roller -1 no.

5. Submission of EMD and cost of Tender Documents

The cost of tender document is ₹.1000/- (Rupees one thousand only) for work costing more than 50 lakhs and ₹.500/- (Rupees five hundred only) for work costing less than 50 lakhs and ₹.150/- (Rupees one hundred and fifty only) for work costing less than1 lakh plus GST 5%(Non-Refundable) The cost of EMD and tender document (as noted in column 5 & 6 of the table above) are to be remitted in online mode.

- 6. On the scheduled Time and date of opening, the Commissioner Pondicherry Municipality authorizes the opening of e-tender on the notified time. Contractor can access the particulars, after opening of e-tender in the website. The Municipality will not be liable for any delay in submission of e-tender.
- 7. The Contractor / Contracting firm should enclose a copy of the certification of registration issued by the "Employees' provident Fund Organization" along with EMD in the technical bid, in the form of Scanned copy otherwise no payment will be made to the bill under consideration.
- 8. A Copy of the enlistment of contractor license issued by the competent authority (i.e.) Copy of Registration should be scanned and uploaded. The tendering limit mentioned in the Enlistment copy shall be taken in to consideration for the eligibility of the Contractor. Bids submitted by the contractors who are not having required tendering limit shall be summarily rejected.
- 9. For Contractors other than those registered in PWD. Puducherry should produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed works of magnitude specified in the first paragraph of this Tender Notice. The scanned copy of the proof should be uploaded in Form C.
- 10. The time allowed for carrying out the work as noted in column No.8 of the table above will be including monsoon period.
- 11. If the last date of opening day of tenders happens to be Public Holiday the same will be opened on next working day.

- 12. The Commissioner Pondicherry Municipality reserves the right to reject any or all the tenders without assigning any reason thereof.
- 13. This work is covered under Puducherry Goods and Services Tax Act 2017 and hence the contractors are requested to quote the rates including the effect of GST. Additional / Separate claim for GST will NOT be entertained on any account after the award of work. The payment is also liable for TDS as instructed by the Commercial Tax Department based on GST.
