Puducherry and the contractors not registered with PWD, Puducherry but registered in other state Government / PSU should produce documentary evidence in support of their having satisfactorily three similar completed works costing not less than 40% of estimated cost put to tender or two similar completed works costing not less than 50% of estimated cost put to tender or one similar completed works costing not less than 80% of estimated cost put to tender in the last seven years ending previous day of last date of submission of tenders. (Similar work means execution of Building / Roads/Drain works). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of submission of tenders. The contractor after purchasing the valid key and Digital signature Certificate can only be able to download the Tender Notice, Notice Inviting Tender and other related documents and upload the bid document online by verifying the Tender Number assigned for each work from https://pudutenders.gov.in.

## (ii) For works costing more than Rs.3.00 crores
