3. Submission of EMD and cost of Tender Documents should be credited as detailed below:

The cost of tender document is Rs.1,500/- (Rupees one thousand five hundred only) for above 2.00 crores, ₹.1,000/- (Rupees one thousand only) for work costing more than 50 lakhs and ₹.500/- (Rupees five hundred only) for work costing less than 50 lakhs and ₹.150/- (Rupees one hundred and fifty only) for work costing less than 1 lakh plus GST 5%(Non-Refundable) The cost of EMD and tender document (as noted in column 5 & 6 of the table above) are to be remitted in online mode.

The contractor shall remit EMD and cost of tender schedule on or before the closing date and time for submission of e-tender through online by Internet Banking or NEFT/RTGS modes. In Internet banking, bidders shall make payments using his/her Internet Banking enabled account with any of the banks listed in the **Annexure** enclosed. The payment Gateway will display a list of banks wherein the bidder has to choose his/her bank. Upon selection, the bidder will be taken to the login page of his/her bank. The bidder has to login and proceed for paying the Tender fees/EMD. If the transaction is successful, system will be redirected to the e-Tendering portal for submission of bid.

To facilitate Bidders who do not have Internet banking facility, payment can be made offline through NEFT/RTGS mode. - 6. The Contractor / Contracting firm should enclose a copy of the certification of registration issued by the "Employees' provident Fund Organization" along with EMD in the technical bid, in the form of Scanned copy otherwise no payment will be made to the bill under consideration.
- 7. A Copy of the enlistment of contractor license issued by the competent authority (i.e.) Copy of Registration should be scanned and uploaded. The tendering limit mentioned in the Enlistment copy shall be taken in to consideration for the eligibility of the Contractor. Bids submitted by the contractors who are not having required tendering limit shall be summarily rejected.
- 8. For Contractors other than those registered in PWD. Puducherry should produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed works of magnitude specified in the first paragraph of this Tender Notice. The scanned copy of the proof should be uploaded.
 - 9. The contractor should submit a self-declaration showing the details of work on their hand in the form of scanned copy.
- 10. The list of documents to be enclosed are specified in the N.I.T and the said documents must be clearly displayed and seen by the Tender Opening Authority before opening of Financial bid.
 - 11. The time allowed for carrying out the work as noted in column No.8 of the table above will be including monsoon period.
 - 12. If the last date of opening day of tenders happens to be Public Holiday the same will be opened on next working day.
