3. Eligibility conditions for the Bidder

Condition stipulated for all works

“The Contractors who are having three works or more on hand at the time of tendering are not eligible to participate in the tender” (PWD/ OTHER THAN PWD CONTRACTORS). The participating contractor shall submit the list of works in hand (progress) in Letter pad and it should be enclosed along with tender documents sealed cover.

4. Submission of EMD and cost of Tender Documents:

The Cost of tender document is Rs. 500 + GST.

The Earnest money Deposit and the cost of tender documents (as mentioned in column 4 and 7) are in the form of Demand draft / Fixed Deposit Receipt of any Nationalized / Scheduled Bank are to be drawn in favour of the Commissioner, Pondicherry Municipality, Puducherry on the above stipulated dates and it should be enclosed along with tender documents sealed cover.

5. A Copy of the enlistment of contractor license issued by the competent authority should also be submitted. (i.e.) Copy of Registration.

6. The Contractor / Contracting firm should enclose a copy of the certification of registration issued by the “Employees’ provident Fund Organization” along with tender documents otherwise no payment will be made to the bill under consideration.

7. The contractor should submit a self-declaration showing the details of work on their hand and invariably the contractor should sign all the pages of Notice Inviting Tender while submission.

8. The time allowed for carrying out the work as noted in column No.6 of the table above will be including monsoon period.

9. If the opening day of short tender happened to be Public Holiday the same will be opened on next working day.

10. The Commissioner reserves the right of rejecting any or all the tender without assigning any reason thereof.

11. The short tender shall be submitted to the Office of the Commissioner in the tender box kept in the chamber of the Commissioner, Pondicherry Municipality, Puducherry.

12. This work is covered under Puducherry Goods and Services Tax Act 2017 and hence the contractors are requested to quote the rates including the effect of GST. Additional / Separate claim for GST will NOT be entertained on any account after the award of work. The payment is also liable for TDS as instructed by the Commercial Tax Department based on GST.
