**'e' TENDER NOTICE**

On behalf of the Pondicherry Municipal Council, tenders through e-Tendering are invited by the undersigned from the eligible Electrical Contractors Grade 'A' or Grade 'B' valid Electrical Contractor License issued by the Union Territory of Puducherry or other States with permission procedure of Puducherry Electricity Department should produce documentary evidence in support of their having satisfactorily three similar completed works costing not less than 40% of estimated cost put to tender or two similar completed works costing not less than 60% of estimated cost put to tender or one similar completed works costing not less than 80% of estimated cost put to tender in the last seven years ending previous day of last date of submission of tenders. (Similar work means execution of Out Door Street Lighting/ Decorative Lights/ Out Door Lightings with proper laying of UG Cable works with control gear arrangements for the respective works with minimum of 50 Nos Decorative/Street Lighting Poles and above with proper Completion Certificates issued by the Government Departments/Quasi Government/Local Bodies). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of submission of tenders. The contractor after purchasing the valid key and Digital signature Certificate can only be able to download the Tender Notice, Notice Inviting Tender and other related documents and upload the bid document online by verifying the Tender Number assigned for the work from [www.pudutenders.gov.in](http://www.pudutenders.gov.in).

2. Tender Schedule can be downloaded and submitted online through the website <https://pudutenders.gov.in> only by those contractors, who are having valid ikey and Digital Signature Certificate and the tender Schedules cannot be purchased from the Office of the Executive Engineer Pondicherry Municipality by remitting the cash in the Office of the Executive Engineer and no pre request for issue of tender schedules will be entertained in the office of the Executive Engineer.

**3. Submission of EMD and cost of Tender Documents should be credited as detailed below:**

The cost of tender document is Rs.1,500/- (Rupees one thousand five hundred only) for above 2.00 crores, ₹.1,000/- (Rupees one thousand only) for work costing more than 50 lakhs and ₹.500/- (Rupees five hundred only) for work costing less than 50 lakhs and ₹.150/- (Rupees one hundred and fifty only) for work costing less than 1 lakh plus GST 5% (Non-Refundable) The cost of EMD and tender document (as noted in column 5 & 6 of the table above) are to be remitted in online mode.

The contractor shall remit EMD and cost of tender schedule on or before the closing date and time for submission of e-tender through online by Internet Banking or NEFT/RTGS modes. In Internet banking, bidders shall make payments using his/her Internet Banking enabled account with any of the banks listed in the **Annexure** enclosed. The payment Gateway will display a list of banks wherein the bidder has to choose his/her bank. Upon selection, the bidder will be taken to the login page of his/her bank. The bidder has to login and proceed for paying the Tender fees/EMD. If the transaction is successful, system will be redirected to the e-Tendering portal for submission of bid.

To facilitate Bidders who do not have Internet banking facility, payment can be made offline through NEFT/RTGS mode. In this option, the bidder has to take print-out of the NEFT/RTGS payment Challan auto-generated by the system and visit his/her bank to remit the requisite amount. Once payment is received in the pooling account the bidders will be able to proceed for bid submission by feeding the Unique Transaction Reference (UTR) number in the e-procurement portal. **It is advised that the bidders make payment one day in advance for validation purpose.** ICICI Banks shall handle the queries of the bidders regarding online payment.

4. On the scheduled Time and date of opening, the Commissioner Pondicherry Municipality authorizes the opening of e-tender on the notified time. Contractor can access the particulars, after opening of e-tender in the website. The Municipality will not be liable for any delay in submission of e-tender.

5. Form 6 is available on the website [www.pudutenders.gov.in](http://www.pudutenders.gov.in) and the same can be viewed online by the intending contractors.

**6. The Contractor / Contracting firm should enclose a copy of the certification of registration issued by the "Employees' provident Fund Organization" along with EMD in the technical bid, in the form of Scanned copy otherwise no payment will be made to the bill under consideration.**

7. A Copy of the enlistment of contractor license issued by the competent authority (i.e.) Copy of Registration should be scanned and uploaded. The tendering limit mentioned in the Enlistment copy shall be taken in to consideration for the eligibility of the Contractor. Bids submitted by the contractors who are not having required tendering limit shall be summarily rejected.

8. The contractor should submit a self-declaration showing the details of work on their hand in the form of scanned copy.

9. The list of documents to be enclosed are specified in the N.I.T and the said documents must be clearly displayed and seen by the Tender Opening Authority before opening of Financial bid.

10. The time allowed for carrying out the work as noted in column No.8 of the table above will be including monsoon period.

11. If the last date of opening day of tenders happens to be Public Holiday the same will be opened on next working day.

12. The Commissioner Pondicherry Municipality reserves the right to reject any or all the tenders without assigning any reason thereof.

13. This work is covered under Puducherry Goods and Services Tax Act 2017 and hence the contractors are requested to quote the rates including the effect of GST. Additional / Separate claim for GST will NOT be entertained on any account after the award of work. The payment is also liable for TDS as instructed by the Commercial Tax Department based on GST.
