### NOTIFICATION

Puducherry and Karaikal may also, if satisfied as provided in sub-section (2) of the said section, exercise the powers conferred by the said sub-section for a period of three months from 28th October, 1981 in the Home Department's Notification issued in G.O.Ms.No.61. dated 28<sup>th</sup> October, 1981;
