**Note:** Required mentioned tentative quantity may extend up to 2400 MT and if at all required the separate purchase order may be issued after completion of 1800 MT Cattle Feed supplied.

The Cattle feed should be in the form of MASH type. The cattle feed shall be free from harmful constituents, metallic pieces and adulterants. The cattle feed shall be free from fungal growth and insect infestation and free from fermented, musty, rancid or any other objectionable odor.

**1. General Terms: -**

- a. The Pondicherry Co-operative Milk Producers' Union Ltd. (**PONLAIT**), invites two bid systems single stage two envelopes unconditional Bids from the interested Registered Cattle Feed Manufacturers /Co-operative Institutions in India from within and outside Union Territory of Puducherry through registering and enrolment in online tendering system in <https://pudutenders.gov.in> for the supply of Cattle Feed (MASH) for PONLAIT at Pondicherry regions. Bidders may quote the rate and submit bids for Mash type only as mentioned in the BOQ.
- b. First download NIT documents namely Tender Notice, Terms and Conditions, Bidder Instructions, Technical Specifications and BOQ File (Price Bid) from the Tender published in the website [www.pudutenders.gov.in](http://www.pudutenders.gov.in) and [www.py.gov.in](http://www.py.gov.in) read all the terms and conditions of the two part tender before uploading the files in the website.
- c. The successful bidders themselves will have to procure permits, license etc., that may be required in fulfilling the contract. Conditional offers as binding the PONLAIT, or offers requesting the PONLAIT for arranging the release of Molasses, will not be accepted. Therefore, only those bidders who are having valid license for transporting and usage of molasses at the time of opening of tender, are eligible to participate in the tender.
- d. The quotation for the supply remains open for a period of one year from the date of opening of the Financial / Price Bid.
- e. Bids received after the specified date and time shall be summarily rejected.

adherence of quality specification mentioned in the Technical Specification of the e-Tender and the decision of the PONLAIT is final.

- q. L1 rate (lowest rate) will be calculated based on the item-rate lowest rate per Kg.
- r. **Only the terms and conditions as specified in this tender by the PONLAIT shall be binding on the bidder and the tendering authority.**
- s. Bidders are requested to strictly confirm to the instructions and attach their enclosures which should be clear scanned copies and no variation in the Proforma will be permitted (As per Annexure – I).
- t. The Managing Director, Pondicherry Co-operative Milk Producers' Union Ltd., reserves the right to postpone, or cancel the tender. Notwithstanding anything contained in the tender schedule, no obligation will rest on the PONLAIT to accept the lowest bid and the PONLAIT shall also have the right to extend/accept or reject any or part or all of the tender.
- u. At the time of supply, cattle feed samples (3 Nos.) shall be drawn from each consignment, pooled and one sample shall be given to supplier on request, one shall be stored for future reference and the other shall be used for analysis of quality at PONLAIT Quality Assurance Laboratory
- v. The Cattle Feed (Mash) supplied shall be analyzed at the PONLAIT Quality Assurance Laboratory. The quality results so declared by the PONLAIT Quality Assurance Laboratory shall be final.
- w. If the PONLAIT incurs any loss due to the default of the bidder on account of supply of poor quality cattle feed, then the same will be recovered from the bidder or from any other transaction of the bidder with this PONLAIT or through arbitration mutually agreed upon.

- x. In case of partial / short supply of the ordered quantity of the cattle feed, bill amount for the quantity supplied will be settled only after deducting short supply quantity amount as well as the security deposit will be forfeited. Defaulters due to non-supply of the ordered quantity of cattle feed in the tender within the prescribed time schedule will be debarred in the subsequent tender.
- y. Delayed supply due to strikes, lockouts, fire accidents or any other bonafide causes beyond the reasonable control by the bidder and such delay or impediment occurs before the time of supply it shall be the duty of the bidder to set forth this case and request for extension of time for supply.

- vi. Copy of valid GST Registration Certificates and documents shall be enclosed.
- vii. Section 194 Q of the Income Tax Act, 1961 shall be strictly adhered and documents / declarations relevant to this shall be enclosed for three Assessment year (2018-19, 2019-20 & 2020-21).

- c. PART-I Technical Bid, wherein the pre-qualification, based on various factors such as supply capacity, suitability and eligibility of the bidders will be evaluated, considered and decided prior to opening of price bids under PART-II of the tender.

- d. On termination of the contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by legal means apart from forfeiture of any amount due to the successful bidder.
- e. No exemption will be given for payment of Security Deposit.
- f. No interest shall be paid on Security Deposit.

- d. The cattle feed required should be supplied in HDPE bags with Net Weight of 50 kgs as required (Exclusive of packing) (HDPE bag specification: size 28" X 42", mesh: 10 X 10, weight 115 grams (+/-) 5 grams, with double colour printing).
- e. The cattle feed should be supplied at convenient intervals as required by the PONLAIT and supply of cattle feed should be effected within 10 days from the date of receipt of every supply schedule order from the Managing Director, The Pondicherry Co-operative Milk Producers' Union Ltd., Puducherry and the bill will be settled within sixty days of receipt of bill.
- f. The number and the quantity given in the schedule are only approximate and are liable to vary according to the actual requirements. The successful bidder should supply the items indented upon as and when required without reducing the quantities.
- g. The bidder should supply the Cattle feed within 10 days (ten days) from the date of receipt of the Purchase Order, failing which the items required will be met by other sources. The extra cost involved, if any will be charged from the bidder.
- h. The bidder should supply Cattle feed as per the Purchase Order in full and piecemeal supply will not be entertained.

**12. Grounds for termination of contract and procedure for termination: -**

THAT, the parties agree that any dispute or difference whatsoever arising between the parties out of / under or in connection with or relating to the construction, meaning, scope, operation, or effect of the contract or the validity or the breach thereof shall be referred to a Sole Arbitrator as appointed under clause (IV) herein below, and that the award made in pursuance thereof shall be binding on the parties;
- II. AND THAT, the parties agree that in respect of those matters, as are not defined in the terms and conditions of the main contract, or in this Arbitration Agreement, the same shall be decided and settled by the Sole Arbitrator in accordance with the Arbitration and Conciliation Act, 1996 and the amendments thereof as in operation on the date of execution of the Contract;
- III. AND THAT, the parties agree that the place of Arbitration shall be at Pondicherry in the Union Territory of Puducherry;
- IV. AND THAT, whenever the parties decide to resort to Arbitration for dispute resolution, the Managing Director, The Pondicherry Co-operative Milk Producers' Union Ltd. (PONLAIT) shall be the authority to appoint the Sole Arbitrator from amongst a panel of Arbitrators maintained by the Government of Puducherry, and such appointment shall be binding on both the parties:  
Provided that before requesting the Managing Director, The Pondicherry Co-operative Milk Producers' Union Ltd. (PONLAIT) for appointing an Arbitrator, the parties shall make a sincere attempt to resolve their dispute, within a time period of 3 months, through mutual conciliation, and if so felt necessary by the parties under the supervisory guidance of the Managing Director, The Pondicherry Co-operative Milk Producers' Union Ltd. (PONLAIT).
- V. AND THAT, all costs relating to the Arbitration proceedings, shall be borne equally by both the parties;



- VI. AND THAT, the parties agree that the language for making all submissions and evidence will be presented in ENGLISH during the proceedings;
- VII. AND THAT, it is agreed between the parties that they shall extend their fullest support and co-operation to the Sole Arbitrator and not seek adjournment of the Arbitration proceedings, without explaining the reasons therefor, in writing, in advance, for seeking of such adjournment, and further that there shall not be more than two such adjournments granted, even when there exists a valid reason for seeking such adjournment. And it is further agreed that the parties should cooperate in completing the arbitration process and the broader dispute resolution within 6 months or at most with an extension, on mutual consent, of another 6 months;
- VIII. AND THAT, it is agreed by the parties hereto that, in so far as there is an arbitral award for payment of money, the Sole Arbitrator may include in the sum for which the award is made, interest at the RBI repo rate, as on the date on which the cause of action arose, plus 2 % on the whole, or any part of the money, for the whole or any part of the period, between the date on which the cause of action arose and the date on which the award is made:

Provided that, on the sum so directed to be paid by an arbitral award, there shall be no interest payable for three months commencing from the date of award, but thereafter, interest shall be payable at RBI repo rate plus 4% for such period of delay, till the date of payment;

- IX. The Arbitrator shall record, in writing, the arguments of the two parties on each of the points of dispute and pass a speaking order thereon.
- X. AND THAT, in so far as Arbitration is concerned, the terms and conditions of this Chapter shall prevail over anything to the contrary that may be spelt out in the contract agreement.

- v. Bidder then log-in to the site through the secured log-in by entering their user ID/password and the password of the Digital Signature Certificate.

### **3. SEARCHING FOR TENDER DOCUMENTS**

- i. There are various search options built in the e-Procurement Portal, to facilitate bidders to search active tenders by several parameters. These parameters include Tender ID, Organization Name, Location, Date, Value, etc.
- ii. Once the bidders selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the e-Procurement Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- iii. The bidder should make a note of the unique Tender ID assigned to each tender; in case they want to obtain any clarification/help from the helpdesk.

### **4. PREPARATION OF BIDS**

Bidder should take into account corrigendum published on the tender document before submitting their bids.

- i. Please go through the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents – including the name and content of each of the documents that need to be submitted. Any deviations from these may lead to rejection of the bid.
- ii. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document and generally they can be in PDF format. Bid documents may be scanned with 100 dpi which helps in reducing the size of the scanned document. The maximum size of the bid document shall not exceed 35 MB.



## **5. SUBMISSION OF BIDS**

- i. Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission date/time. Bidder will be responsible for any delay due to other issues.
- ii. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- iii. All the documents being submitted by the bidders will be encrypted using PKI encryption techniques to ensure secrecy of data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. Confidentiality of bids is maintained using the Secured Socket Layer (SSL) 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further, this key is subjected to asymmetric encryption using Department's bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- iv. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- v. Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission acknowledgment which is downloadable/printable. This acknowledgment may be used as an entry pass for any bid opening meetings.

## **6. ONLINE PAYMENT OF EMD & TENDER FEES**

In Internet banking, bidders shall make payments using his/her internet Banking enabled account with any of the banks listed in the Annexure enclosed. The Payment Gateway will display a list of banks wherein the bidder has to choose his bank. Upon selection, the bidder will be taken to the login page of his/her bank.
