TERMS AND CONDITIONS OF THE ONLINE AUCTION
FOR THE SALE OF FOUR CONDEMNED CRANES

1	The bidders can download the e-auction documents from the Government e-auction website https://eauction.gov.in No e-auction bids to be sealed and brought to the Port Department, Puducherry for placing in the tender box
2	The intending bidders before participation in the online Auction/ bid process will be required to have individual Digital Signature Certificate on their own and to create their users account online by selecting the option of auction from discipline column and obtain user id /password in the website https://eauction.gov.in (if already created users account, this step needs to be skipped). For necessary guidelines regarding participation in online auction please visit the above mentioned website and click on the available link Information about Digital signature certificate at the home page for their frequently asked questions (FAQS) regarding online bidding process.
3	Intending bidders will mandatorily be required to sign-up online (create user accounts) by selecting discipline Auction on the website https://eauction.gov.in to be eligible to participate in the online auction. The e-auction schedule shall be available in the e-auction website from 10.00 hrs. on 29-06-2020.
4	The Bidder shall submit cost of Tender Schedule with GST and EMD in two separate DDs in favour of the Executive Engineer, Port Department, Puducherry drawn in any Nationalised Bank, payable at Puducherry and reach the Office of the Executive Engineer, Port Department, No.1, Dumas Street, Puducherry on or before 20-07-2020 upto 17.00 hrs.
5	The following self attested documents shall be submitted in the Office of the Executive Engineer, Port Department, Puducherry on or before 20-07-2020 upto 17.00 hrs. i. Valid GST certificate . ii. Pan card as proof of Identity. iii. Aadhar card or any valid documents as proof of address.
6	The bidders who made payment can only be able to participate in live e-auction after the approval of the Auction Committee. Those approved bidders may participate in the online auction by submitting/placing his/her bids in the e-auction website https://eauction.gov.in on from 10.00 hrs. on 27-07-2020 upto final conclusion of e-auction portal.
7	Bidders are requested to stick on strictly to the date and specified time. Bidders are requested to read the instructions on the available link "Help for contractors" at the Home page of website https:// eauction.gov.in before submission of bids through online.

9	<p>All the four cranes will be sold as a single lot only on "as-is-where-is" condition and "as-is-what-is" basis at the scrap rate per kg.</p>
10	<p>Bid Incremental Value: The minimum bid increment will be in multiple of Rs. 2/- (Rupees Two only) per Kg.</p>
11	<p>It is the sole responsibility of the bidder to inspect the cranes physically in working hours on any of the working days with the permission of Head of Office, before quoting any price for the same.</p>
12	<p>The online auction for the disposal of 4 condemned cranes will start on 27-07-2020 at 10.00 A.M. and will conclude (close) on the same day at 4.00 p.m.</p>
13	<p>Goods and Services Tax (GST), as applicable at the time of rules in force shall be charged extra, over and above the highest Bid Amount.</p>
14	<p>Bid Submission:</p> <p>(a) Any bidder interested to participate in the e-auction can submit his bid/s through online from 10:00 hrs. to 16:00 hrs. on 27-07-2020</p> <p>(b) However, in case any bid in respect of any crane/item is received 05 minutes prior to time fixed for the closure for the bid, then the time of closure of the entire e-auction in respect of all the items would be extended automatically by 5 minutes, so that equal opportunity is made available to the persons participating in the bidding process.</p> <p>(c) In case, the bidding continues during such extension of 5-5-5 minutes, the bidding process will be finally concluded by e-auction portal.</p> <p>(d) The bids offered/received during the e-auction process shall be provisionally accepted and will be subject to final approval of the Director, Port Department, Puducherry.</p>
15	<p>Decision of e-auction: The decision of the e-auction will be as under:</p> <p>(a) After the closure of online auction, the online bids received will be put up before the Auction Committee for the final acceptance/rejection of the bid.</p> <p>(b) The above committee reserves the right to accept/reject any bid without assigning any reason thereof.</p> <p>(c) The proceedings of the Auction Committee as above shall be approved by the undersigned.</p> <p>(d) Acceptance letters for rates and the proportionate amount required to be deposited shall be sent to the successful bidders to their address.</p>

16	Deposit of Sale Value of the Cranes: The bidder whose highest bid has been accepted would be issued the acceptance letter mentioning the proportionate amount to be deposited. On receipt of the Acceptance letter, the highest bidder shall be required to deposit the proportionate amount that was mentioned in the letter, on the very next working day in the office of the Executive Engineer, Port Department, Puducherry.
17	Release Order for Cranes: On receipt of documentary proof of deposit of proportionate amount, the Auction Committee will issue Release Order for delivery of Cranes to the successful bidder.
18	Terms of Delivery: The Cranes will be delivered to the successful bidder in as-is-where-condition for making weighment in the Departmental Weighing Machine and the final amount along with GST will be collected /adjusted accordingly after making weighment calculation.
19	Transfer of Registration No. of 3 cranes: The Port Department will allow the successful bidder to transfer the Registration Number for 3 cranes registered with Transport Department, Puducherry at bidder own risk.
20	Refund of Participation Fees (EMD): (a) In case of unsuccessful bidders (whose rates are not highest), the EMD will be refunded within 2 working days from the date of close of Online Auction. (b) In case of successful bidders, whose rates have been accepted and acceptance letters has been issued in this regard, their participation fees (EMD) shall be retained till the time of completion of payments and delivery process. Once the successful bidder deposits the full Sale Value of the cranes with GST and after taking delivery of the cranes within the specified time period their EMD will be refunded or adjusted against the sale value of the Cranes.
21	Forfeiture of Participation Fees (EMD): The EMD will be forfeited if the successful bidder fails to deposit the requisite Sale Value along with GST of Cranes within the stipulated period after issuance of the acceptance letter to his/her favour.
22	After downloading this tender schedule it is understood the bidder has fully read the terms and conditions herein mentioned.
23	The decision of the undersigned will be final in all cases.
24	All the cases of dispute, if any, will be subject to jurisdiction of Puducherry Region.
