 - (b) Atleast five Master Plans Comprehensive Development Plan / Zonal Development Plans / Detailed Development Plan / Heritage conservation Plan should have been completed and implemented by the stakeholders.
 - (c) Must have applied Geographical Information System (GIS) enabled planning and tools for urban planning and decision making.
 - (d) The consultancy company/firm/consortium must have the following multidisciplinary professionals: Urban / Housing / Environment / Transportation / Infrastructure Planners, Conservation Architects / Urban Designers, Structural / Environmental / Public Health / Traffic and Transportation/ Electrical Engineers, Economist, Sociologist, Geographer, Demographer, Qualified surveyors and Geographical Information System (GIS) professionals.

 - (d) Financial status indicating annual turnover.
