The following notification shall be published in the next issue of the Official Gazette of Puducherry.

NOTIFICATION

In exercise of the powers conferred by sub section (1) of Section 60 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and full participation) Act, 1995 (Act No.1 of 1996), the Lieutenant-Governor, Puducherry hereby makes the following rules further to amend the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Rules, 1998, namely:-

1. (i) These Rules may be called the Persons with Disabilities (Equal Opportunities, Protection of Rights, and Full Participation) (Amendment) Rules, 2011.  
(ii) These rules shall come into force on and from the date of its publication in the official Gazette.

2. Amendment of short title.- In the Persons with Disabilities (Equal Opportunities, Protection of Rights, and Full Participation) Rules, 1996, hereinafter referred to as the said rules, in sub-rule (1) of rule 1, after the word 'Protection of Rights and Full Participation' within brackets, the word 'Puducherry' shall be inserted.

3. Amendment of rule 40.- In the said rules, for rule 40 in chapter VII, the following shall be substituted namely:-

"40. Appointment of Commissioner for Persons with Disabilities:- The Commissioner for Persons with Disabilities shall be appointed by the Administrator/Lieutenant-Governor in accordance with the provisions contained in the Act or the Commissioner for Persons with Disabilities for the Union Territory of Puducherry (Conditions of Service and Terms of Office) Rules, 2011."
