3. Submission of EMD and cost of Tender Documents should be credited as detailed below:

The contractor shall remit EMD and cost of tender schedule on or before the closing date and time for submission of e-tender through online by Internet Banking or NEFT / RTGS modes. In internet banking bidders shall make payments using his / her Internet Banking enabled account with any of the banks listed in the **Annexure enclosed**. The payment Gateway will display a list of banks wherein the bidder has to choose his / her bank. Upon selection, the bidder will be taken to the login page of his / her bank. The bidder has to login and proceed for paying the Tender fees / EMD. If the transaction is successful, system will be redirected to the e- tendering portal for submission of bid.

To facilitate Bidders who do not have Internet Banking facility, payment can be made offline through NEFT / RTGS mode. In this option, the bidder has to take print-out of the NEFT / RTGS payment Challan auto-generated by the system and visit his / her bank to remit the requisite amount. Once payment is received in the pooling account the bidders will be able to proceed for bid submission by feeding the Unique Transaction Reference (UTR) number in the e-procurement portal. **It is advised that the bidders make payment one day in advance for validation purpose.** ICICI Banks shall handle the queries of the bidders regarding online payment.
