On behalf of the President of India, tenders are invited through e-Tendering by the <u>Executive Engineer</u>, Irrigation Division, <u>Public Works Department</u>, <u>Puducherry</u>, for the following work from the eligible contractors/firms who are registered with Public Works Department, Puducherry. <u>Contractors other than those registered with P.W.D.</u>, <u>Puducherry</u> should produce documentary evidence in support of their having satisfactorily completed three similar works each of 40% of estimate cost put to tender or two similar works each of 60% of estimate cost put to tender or one similar work of 80% of estimate cost put to tender in the last <u>7 (seven) years ending previous day of last date of submission of tenders</u>. (Similar work means formation of earthern embankment). The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders. The contractor after purchasing the valid ikey and Digital signature Certificate can only be able to download the Press Notice, Notice Inviting Tender and other related documents and upload the bid document online by verifying the Tender Number assigned for each work from <u>www.pudutenders.gov.in</u>

All the contractors should provide list of works under execution or awarded duly signed with the tender in "Form D".

Contractors NOT registered with PWD Puducherry shall upload the "Form C" that the statement of detail of completed works as per the eligibility criteria specified in the NIT.

The Executive Engineer, Irrigation Division, PWD, Puducherry may reserve the right to change the opening time and date of the Tender for administrative reason by notifying the same in the website.

Tender schedule can be downloaded and submitted online through the website www.pudutenders.gov.in only by those contractors, who are having valid ikey and Digital Signature Certificate and the tender schedules cannot be purchased from the Office of the Executive Engineer by remitting cash and no pre request for issue of tender schedules will be entertained in the Office of the Executive Engineer.

The contractors shall submit EMD and e-tender processing fee on or before the closing date and time of submission of tender through online through NEFT/RTGS/DIRECT DEBIT modes only for which necessary challan will be available in the website. This office will not be responsible for any delay in the realization of EMD / e-tender processing fee. The contractors who had downloaded the Tender Schedule from the website that submit the Tender Schedule online before the scheduled time of submission. (Tender schedule hrough to file of the Executive Engineer for placing in the Tender box is not allowed).

On the scheduled Time & date of opening, the Executive Engineer authorizes the opening of tender on notified time. Contractor can access the particulars, after opening of tender in the web site. The Department was not be liable for any delay in submission of tender.

The time allowed for carrying out the work will be 6 (Six) Months including monsoon period from the date of start as defined in Schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.

The debris should be removed from the site on day to day basis without affecting the public in general.

The mixing of concrete should be done at a separate site avoiding stacking of material at road side.

The Contractor must do their own arrangements at their own cost for signage/barricading etc. for the safety of Public during construction in the construction site of building/road/drain/canal/bridge/culverts etc. No separate claim will be admitted in this regard.
