The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders. ALL Contractors should satisfy Bidding Capacity conditions as stipulated in the Notice Inviting Tender. (No tender schedule brought to the Office of the Executive Engineer for placing in the Tender box is allowed).

On the scheduled Time & date of opening, the Executive Engineer authorizes the opening of tender on the notified time. Contractor can access the particulars, after opening of tender in the web site. The Department will not be liable for any delay in submission of tender.

The General Conditions of Contract for PWD Works 2014 (Form 7/8) is available on the website https://pwd.py.gov.in/ and the same can be viewed online by the intending contractors.

The time allowed for carrying out the <u>each work will be FOUR (04)</u> Months (including monsoon period) from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.

The debris should be removed from the site on day to day basis without affecting the public in general.

The mixing of concrete should be done at a separate site avoiding stacking of material at road side.

The Contractor must do their own arrangements at their own cost for signage/barricading etc. for the safety of Public during construction in the construction site of building/road/ drain/canal/bridge/culverts etc. No separate claim will be admitted in this regard.

The e-tender processing fee & EMD should be deposited only through NEFT/RTGS/Direct Debit mode available in the website. The e-tender processing fee should be drawn in favour of the Executive Engineer, Irrigation Division, PWD, Puducherry.
