Expression of Interest

The Executive Engineer, AFD Project Unit (PU), PWD, Puducherry has received a financing from the Agence Française de Développement (AFD) for "Augmentation of Water Supply Sources and Rehabilitation of System in Urban Area in Puducherry District, Puducherry, (Phase-I)" for which he intends to engage an external expert Technical Assistance (TA) to support the AFD Project Unit, PWD and to support the Public Health Division, PWD for the improvement of the overall performance of the water service by utilizing a part of the funds thereof for payments.

The Services of the consultant shall consist of

- a) **Technical Assistance**(TA) to support the AFD Project Unit, PWD to roll-out the project
- b) **Technical assistance** to improve the existing **water service operation** of PWD.
- c) Water Demand Study, and Water Resource Identification and Optimization Study
- d) Detailed engineering activities required for preparation of Detailed Project Report, estimates, BOQ, detailed good for construction drawing, detailed rate analysis, Bill of Quantities, structural & hydraulic design of **Water Supply** infrastructures, geo technical investigation and cost benefit ratio (IRR & ERR) corresponding to each and every work package.
- e) Preliminary Engineering and Preparation of Detailed project report for the Underground Sewerage System for the left out areas in Puducherry Urban Agglomeration Area (PUAA). PUAA compromises of Municipalities of Pondicherry and Oulgaret and urban areas of Villianur and Ariyankuppam Commune Panchayats.

This service shall be of 5 sub components:

Sub component 1-a: **Technical Assistance** (TA) to implement the proposed infrastructure project

- Sub-component 1-b: Technical Support to the PWD & Public Health Division on Water service operation improvement: network efficiency, financial modelling, GIS/SCADA, metering, customer management, etc.
- > Sub-component 2: Water Demand Study, and Water resource identification and optimization study
- > Sub component 3-a: Detailed Engineering works for the work packages in Water Supply sector.
- > Sub component 3-b: Preparation of detailed project report for Underground Sewerage System in left out areas of PUAA.

The broad scope of service for the TA will be:

Sub component 1-a: TA for project implementation

LTTA will support the AFD Project Unit, PWD in all tasks related to the roll-out of the project:

- (i) To assist the PU in procurement:
 - a. Preparation of the tender of each work package,
 - b. Processing of the tenders,
- (ii) Contribution to monitoring and reporting,
- (iii) Support for the work supervision,
- (iv) Fulfillment of the Environmental and Social Management & commitment plan
- (v) To support the PU in the post commissioning of the infrastructures so created, if necessitated.
- (vi) To prepare a feasibility study to implement 24x7 water supply in different zones of PUAA.
- (vii) To perform Engineering Activities required for preparation of DPR and procurement plan (work package breakdown, cost estimate)

Sub component 1-b: TA for service improvement

The broad scope of service of Technical Assistance, under Sub component 2, will be technical support to the Public Health Division, PWD on the following topics:

(i) Network efficiency: technical assistance to design and assist PWD in the provision of new tools and works processes for an efficient management of the network, including GIS, Hydraulic modeling, and design of a 24/7 pilot zone. (the software would be purchased under separate contracts)

- (ii) Treated water monitoring system and primary network: preliminary design, provision of technical specifications, provision of a XIs monitoring tool for the bulk metering system and training to the PWD teams on the same.
- (iii) SCADA system: preliminary design of the SCADA system to be implemented within the project and provision of the Terms of References for the implementation of the SCADA system
- (iv) Customer management system: support to the PWD to foster the efficiency of the customer management system: improvement of processes, support to the PWD in the selection and implementation of a new customer software, and in the procurement of radio-frequency meters.
- (v) Provision of the Financial modeling of the water service

Sub component 2: Water resource study

The broad scope of service of Technical Assistance, under Sub component 2, will be:

- (i) To conduct an extensive water demand survey in Puducherry region and submit a detailed report on the stakeholders water requirement in long run. (domestic need, agriculture need, industrial need, livestock need, construction activity need, etc)
- (ii) To conduct an extensive scientific assessment in Puducherry region and submit a detailed report on the availability of ground water.
- (iii) To provide advisory note to Project Unit on how to use the available water resources in a sustainable manner (with technical, social, institutional & financial feasibility) without affecting the livelihood of all stakeholders mainly agricultural sector of Puducherry region.
- (iv) To provide detailed report (with technical, social, institutional & financial feasibility) with suitable suggestive measures for reducing the ground water usage by all stake holders by adopting new technological developments in the fields of drip irrigation, changing the cropping pattern, leakage in domestic supply system or any other new system applicable etc.
- (v) To provide detailed project report to maximize the usage of the surface water by suggesting various techniques including creating new

- infrastructures such as planting water storing trees, creating new tanks, rehabilitating the existing water storage structures etc.
- (vi) To conduct extensive study on alternate source of water for domestic consumption and provide detailed report with cost analysis and reliable analysis, sustainable to Government of Puducherry.
- (vii) Upon instruction of the client, set-up a grievance redressal mechanism for the project/support implementation of other recommendations of the SIA report.

Sub component 3-a: Detailed Engineering works in water supply sector

The broad scope of service of Consultant, under this component, will be:

- (i) To prepare detailed estimates, BOQ, detailed good for construction drawing, detailed rate analysis and Bill of Quantities
- (ii) To prepare structural & hydraulic design of water supply infrastructures, geo technical investigation and Cost Benefit Ratio (IRR & ERR) corresponding to the following engineering works.
 - a. OHT, Sump, Distribution Grid, Pumping Main and Road Restoration
 - b. Providing and installation of smart water meter
 - c. Converting the existing water supply distribution grid to supply water to public 24 x 7.
 - d. Sinking 84 Nos. of deep tube wells and its allied works for source augmentation
 - e. Construction of Collection well, pump house, erection of pump set, genset, electrification, etc.
- (iii) To support in preparation of tender documents, fulfilling the Environmental and Social Management & commitment plan

Sub component 3-b: Detailed Design of underground sewerage system

The scope of service of Consultant under this component includes but not limited to Preliminary engineering activities required for preparation of Detailed Project Report, estimates, BOQ, detailed good for construction drawing, detailed rate analysis, structural & hydraulic design of sewerage infrastructures (including networks and treatment), geo technical investigation and cost benefit ratio (IRR & ERR).

(i) Underground sewerage system in the left out areas of PUAA.

- (ii) Revamping of the existing underground sewerage in the PUAA to the projected period of 30 years with modern techniques for operation and maintenance.
- (iii) Assessment of waste water treatment plant(s) capacity and performance, identification of gaps, and if required selection of WWTPs process, including primary, secondary and tertiary treatment as required
- (iv) Preliminary design of waste water treatment plant(s), rehabilitation or construction, depending on client's need.
- (v) Methodology/ scientific approach to achieve 100% house service connection including formulation and implementation of new bye laws if needed.

The consultant has to provide technical assistance to PU until post commissioning of the project for further 6 months if necessitated. The duration of the assignment shall be for a period of 2 years, and extendable based on decision of the client.

Eligibility criteria to AFD's financing are specified in sub-clause 1.3 of the "Procurement Guidelines for AFD-Financed Contracts in Foreign Countries" which is available online on AFD's website www.afd.fr.

Interested consultants shall apply for this service with all documental proofs in support of their eligibilities.

If the consultant is a Joint Venture (JV), the Expression of Interest shall include a copy of the JV Agreement entered into by all members. Alternatively, a letter of intent to execute a JV Agreement in the event of a successful proposal shall be signed by all members and submitted with the Expression of Interest, together with a copy of the proposed Agreement.

If the consultant is a JV, only the lead member is eligible to apply for this EOI.

Determination of the similarity of the experiences will be based on:

The nature of the services provided by the consultant so far:

1) Component 1-a

a. Technical assistance provided in favour of Water supply / Sewerage <u>authorities</u> for projects implementation

2) Component 1-b

a. Technical assistance and/or management contracts provided in favour of Water supply / Sewerage <u>utilities</u> for operational performance improvement

3) Component 2

a. Expertise in recharging and conservation activities of ground water including assessment of ground water availability.

b. Technical assistance in the field of the surface water, minimising the water usage by all stakeholders without affecting their intended needs.

4) Component 3-a and 3-b

- a. Preparation of Detailed Project Reports, estimates, rate analysis, Bill of Quantities etc.,
- b. Hydraulic modelling and design of transmission, transfer and distribution pipeline networks system.
- c. Design of Pumping main and distribution grid in the range from 200mm to 1000mm with a minimum root distance of 150kms.
- d. Surge analysis of transmission mains and pumping stations including corrosion protection works.
- e. Indicative designs and layout plans for retrofitting and development of water supply assets.
- f. Design of bulk metering system and SCADA system.
- g. Structural design of Over Head Tank of minimum capacity of 1ML, Sump, Collection well, Master collection well, pump-house and other RCC structures, including geotechnical works.
- The contracts size and duration;
- The geographic zone where the services took place, and the demonstrated ability to carry out similar projects in the region and/or with spoken language of Tamil and English.

The Client shall also take into account of the following items for evaluation:

- i) Related Experience /previous engagements
- ii) In-house technical back up experts
- iii) Quality assurance procedures and certifications
- iv) Overall financial strength of the consultant in terms of turnover, profitability and cash flow (liquid assets) situation.

The firm should produce the performance report for the works completed indicating the services carried out, project cost, funding agency, period of execution etc., from the client for consideration, failing which that experience will not be considered for evaluation.

The applicants shall submit the signed Statement of Integrity, Eligibility and Social and Environmental Responsibility for evaluation, otherwise application will not be considered.

Appraisal criteria

Each experience submitted by the Applicant, will be appraised, based on the following criteria:

Criterion 1: Long Term Technical assistance in favor of large water supply infrastructure projects (nature of services corresponding to component 1-a above) (250 crores INR or 35 million USD) in the last 5 years.

Criterion 2: Long Term Technical assistance and/or management contracts in favor of large water supply services(nature of services corresponding to component 1-b above) (population served over 250 000) in the last 5 years.

Criterion 3: Consultancy work in the field of Hydrology & Hydrogeology (nature of services corresponding to component 2 above) costing more than 0.7 crores INR or 0.1 million USD in the last 5 years.

Criterion 4: Consultancy work in the design of large-scale water supply systems (Pumping main, distribution grid, hydraulic structures, smart metering and SCADA) (250 crores INR or 35 million USD) in the last 5 years.

Criterion 5: Consultancy work in the design of large-scale wastewater systems, including treatment plants (Networks, pumping, treatment) (250 crores INR or 35 million USD) in the last 5 years.

Criterion 6: The experience took place in the Indian sub-continent (India, Pakistan, Sri-Lanka, Bangladesh, Nepal)

Criterion 7: The experience performed in the context of a project funded by International Financial Institutions.

Selection rules

- The Applicant must have at least **three** experiences meeting **each** of the **criteria** 1 to 5, otherwise the application will be disqualified. However, one experience may qualify two or more criterias.
- For criteria 6 and 7, only references/experiences meeting one of the first five Criteria will be taken into account.
- The ranking of Applicants will be based on the greatest number of criterion fulfilled.
- For a Joint Venture, the experiences of all members will be added together.

General conditions & date of submission

- > The undersigned reserves all rights to cancel or reject this EOI without assigning any reasons.
- > The top six short-listed consultants will be eligible for participation of the Request for Proposal to carry out the consultancy services for the project.
