**ORDER** 

The Government of Puducherry has computerized the Land Records in the Union Territory under a project called NILAMAGAL and has been issuing computerized extract of land records/Register of Rights (RoR) viz., Patta Copy/ Settlement Copy to interested parties on payment of user charges of ₹20/- per page vide G.O. cited above.

- 2. Now under the National e-Governance Plan it is proposed to issue the computerized extracts of land records/register of rights viz., patta copy / Settlement copy through Common Service Centres (CSCs) to be established throughout the Union Territory wherein the said extracts will be provided on payment of specified fees.
- 3. The Government hereby authorizes the CSCs to be established under Puducherry e-Governance Society functioning under the Directorate of Information Technology to issue computerized extracts of Patta Copy/Settlement Copy and further directs that the fees for issue of the computerized extracts comprising statutory charges which accrue to the Department will be as per the G.O. Ms. No.142, dated 5-11-05 read above and the user charges for CSCs will be as fixed by the Department of Information Technology, Puducherry from time to time.
- 4. The Government also directs that the computerized extracts of land records shall be authenticated with digital signature of concerned Specified Officers such as the jurisdictional Tahsildar/ Deputy Tahsildar.
