

#### **GUIDELINES FOR EX-SERVICEMEN OF PONDICHERRY UNION TERRITORY**

#### **Definition of Ex-Serviceman**

- 1. The eligibility of the retired Defence personnel to the status of Ex-Servicemen is governed by the definition as laid down by Department of Personnel and Training. The definition has been undergoing changes from time to time. The following are the broad categorization:-
  - (a) Those Released Before 01 Jul 1968. Any person who has served in any rank whether as combatant or not in the Armed Forces of the Union and as released there from otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
  - (b) Those Released On or After 01 Jul 1968 but before 01 Jul 1979. Any person who had served in any rank whether as a combatant or not in the Armed Forces of the Union for a continuous period of not less than six months after attestation and released there from otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
  - (c) Those Released On or After 01 Jul 1979 but before 01 Jul 1987. Any person who had served in any rank whether as a combatant or not in the Armed Forces of the Union for a continuous period of not less than six months after attestation if discharged for reasons other than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency and not less than five years of Service if discharged at own request.
  - (d) Those Released On or After 01 Jul 1987. Any person who had served in any rank whether as a combatant or not in the Armed Forces of the Union and was released/retired with any kind of pension from Defence Budget or released on completion of specific terms of engagement with gratuity otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency.
- 2. In addition, the personnel of the Territorial Army (TA) of the following categories viz. pension holders for continuous embodied service, persons with disability attributable to Military Service and Gallantry Award Winners retired on or after 15 Nov 1986 and the personnel of the Army Postal Service (APS) who are a part of a regular Army and retired from such service, i.e directly from the APS itself without reversion to P & T Department with a pension or who have been released from such service on medical ground attributable to Military Service or circumstances beyond the control and awarded Medical or other disability pension on or after 19 Jul 1989 are also covered within the definition of Ex-Servicemen.

- 3. In all cases Cadets/Recruits are not Ex-Servicemen. Armed Forces of the Union means the Army, Navy and Air Force of the Indian Union including the Armed Forces of the former Indian States but excludes the persons who have served in Defence Security Corps (DSC), General Reserve Engineering Force (GREF), Lok Sahayak Sena and Para Military Forces.
- 4. The eligibility of the person to the status of Ex-Servicemen will be governed by the definition in vogue at the time of his discharge and will not be affected by the changes in the definition subsequent to his discharge.

#### **CSD** Canteen Facilities

5. In accordance with Army Order 32 of 84, Ex-Servicemen and their families and Ex-Defence personnel with minimum of five years of service are entitled to CSD Canteen facilities available in Units/Establishments. Cadets/Recruits boarded out on medical grounds are also entitled to avail CSD Canteen facilities. In addition TA Personnel released from Service after completion of the specific period of engagement, otherwise than at his own request or by way of dismissal on account of misconduct.

#### Registration with Rajya Sainik Board/Department of Sainik Welfare, Pondicherry.

6. Ex-Servicemen and their Widows are eligible for any concession/benefit only after registration and issue with Ex-Serviceman Identity card/Employment card and Widow Identity card by this Department. Therefore Ex-Serviceman and Widows are required to register their name and obtain Employment Card/Identity Card. The following documents are required for registration:-

#### (a) <u>Ex-Serviceman</u>

- (i) Discharge Certificate.
- (ii) Pension Payment Order. (Both Service & Disability)
- (iii) Three Stamp size, one passport size and one passport size joint latest Photographs.
- (iv) Original and two sets of photocopies of educational qualification (Mark sheets and certificates) for employment purpose.
- (v) Any other related document.
- (vi) Residential Certificate for not less than five years obtained form Thasildar and cancellation/No objection certificate from his previous Board if the Ex-Serviceman has declared his home address of other than Pondicherry (UT) in his Discharge Certificate. In such case the Discharge Certificate will be sent to his Record Office through his previous Board for Publication of Part II order/POR and notification both in his discharge certificate and service documents. On receipt of discharge certificate with his address duly amended by Records, registration will be done.

#### (b) Widow of Ex-Serviceman

- (i) Discharge Certificate, Identity Card and Death Certificate of her late husband.
- (ii) Three Stamp size latest photographs.
- (iii) Pension Payment Order (Both Family Pension and Self service pension if applicable)
- (iv) Residence Certificate for not less than five years and No objection certificate if her late husband not registered earlier.
- (c) <u>Employment Card</u>. Ex-Serviceman will be issued with an Employment card and duly allotted a registration number. Then a copy of Employment card will be sent to local Employment Exchange. As and when Recruiting Department/Agency demand for sponsorship of any post, the names of those who qualify the conditions will be sponsored. Ex-Serviceman has to renew his Employment Card once in three years. Otherwise his name will be deleted from the live register.

## CONCESSIONS/BENEFITS TO EX-SERVICEMEN/WIDOWS FROM GOVERNMENT OF PONDICHERRY.

- 7. The following concessions/benefits are extended to Ex-Servicemen/Widows of Pondicherry (UT):-
  - (a) Reservation in Group "C" and "D" Posts at the rate of 10% and 20% respectively.
  - (b) 3% Reservation in allotment of House sites/Flats to Ex-Servicemen and 2% to Defence Personnel
  - (c) Medical Treatment and allotment of bed in Special Wards to Ex-Servicemen/Dependents on priority at par with Government Employees of Pondicherry (UT).
  - (d) 1% horizontal reservation of seats in all educational institutions to wards of Ex-Servicemen.
  - (e) Priority II in filling up of vacancies through Employment Exchange.
  - (f) Age concession of 3 years more in addition to the period of service rendered in Defence Service for appointment in State/Central Government and Public Sector Undertakings.
  - (g) Cash incentives, cash in lieu of land and Annuity to Armed Forces Personnel of UT of Pondicherry honoured with Gallantry and Distinguished Service Awards as per Gazette of Pondicherry No.87 dated 26 Oct 1999 at par with Central Government rate as per Appx `A`.
  - (h) Financial Assistance to repair damaged huts/houses due floods and cyclones.

- (j) Fair price shops 10% reserved for Ex-Servicemen.
- (k) Priority in sanctioning goods Transport and Bus permit to Ex-Servicemen Co-Op organization.
- (I) Exemption from Physical Efficiency Test for the recruitment of Sub-Inspector of Police and Police Constable posts.

## FINANCIAL ASSISTANCES/GRANTS TO EX-SERVICEMEN/WIDOWS GIVEN THROUGH DEPARTMENT OF SAINIK WELFARE, PONDICHERRY.

The following financial assistances/grants are extended to Ex-Servicemen/Widows through the Department of Sainik Welfare:-

- (a) Subsistence Allowance of Rs.1,500/- per month to Destitute II World War Veterans and their Widows who are not in receipt of any kind of pension/Financial assistance from any source after receipt of discreet enquiry from Tahsildar.
- (b) Spectacle Grant of Rs.500/-, Hearing Aid Grant of Rs.1,000/- and Denture Grant of Rs.5,000/- to Ex-Servicemen/Widows once in life time.
- (c)) Cash assistance of Rs.5,000/- for accident/severe injury of Ex-Servicemen/Widows.
- (d) Children Education Allowance towards tuition fee, book and Uniform to wards of Ex-Servicemen/Widows studying in Class I to XII at prescribed rates once in a year. Re-imbursement of Tuition fees at the prescribed rates of Government for the Professional courses like Engineering, Medical, Dental and Agriculture in colleges located in the Union Territory Pondicherry.
- (e) Re-imbursement for learning typewriting/shorthand/book-keeping courses up to Rs.300/-.
- (g) Cash incentive for first three merit students of X and XII classes at the rate of Rs.1500, Rs.1,200/-, Rs.1,000/- and Rs.2,000/-, Rs.1,500/-, Rs.1,200/- respectively.
- (h) Cash incentive of Rs.5,000/- for outstanding academic merit son/ward of Ex-Servicemen/Widows for Gold Medal/First three positions in the University/Colleges in Graduation and Post Graduation/Ph.D in any discipline.

- (j) Cash incentive for outstanding achievements in Sports to wards of Ex-Servicemen/Widows of Rs.2,000/- for representing University, Rs.5,000/- for State and Rs.10,000/- for Country, and Rs.2,000/-, Rs.3,000/- and Rs.5,000/- for setting record in University, State and National level respectively.
- (k) Marriage Grant of Rs.10,000/- to one daughter of Ex-Servicemen/Widows without income ceiling for PBOR only.
- (I) Death Grant of Rs.5,000/- to the Next of Kin on death of Ex-Serviceman/Widow.
- (m) Stipend of Rs.250/- per month to Ex-Servicemen trainees in I.T.Is
- (n) Issue of Clothing coupon worth Rs.1,500/- to all II World War Veterans (Personnel below Officer rank) and all widows of Ex-Serviceman once in a year.
- (o) Sewing Machines to widows once in life time.
- (p)) Cash incentive Rs.5,000/- and Rs.2,500/- to Ex-Servicemen who acquire B. Ed., and D. T. Ed., qualification respectively.

**Note:** These assistance/grants are admissible to those Ex-Servicemen/Widows whose monthly income is less than Rs.4,000/- for Serial (a) to (d), monthly income is less than Rs.5,000/- for serial (e) & (f) and no income ceiling for serial (g) to (q) above.

#### **NOTIFICATION**

Bye-laws framed by the Rajya Sainik Board, Pondicherry for grant of financial assistance to the ex-servicemen and their dependants.

In pursuance to the provisions contained in paragraph 12 of Schedule B of the notification No. S.R.O. 234 dated 27th September 1966 of the Government of India, Ministry of Defence, the Managing Committee of the Rajya Sainik Board of the Union territory of Pondicherry constituted thereunder, hereby makes the following bye-laws for registration of ex-servicemen and grant of assistance to the ex-servicemen and their dependants registered with the Board, namely:-

#### PART - I

- 1. (1) These bye-laws may be called the Pondicherry Rajya Sainik Board (Registration of Ex-servicemen and Grant of Financial Assistance) Bye-laws, 1981.
  - (2) They shall come into force at once.

## PART- II DEFINITION

- 2. In these bye-laws, unless the context otherwise requires, --
  - (a) "Board" means the Rajya Sainik Board, Pondicherry;
  - (b) "dependant" means the wife, non-earning sons below the age of 21 years, unmarried or widowed daughters, non-earning brothers below the age of 21 years, non-earning unmarried sisters and non-earning parents of the ex-serviceman actually dependant on the ex-serviceman;
  - (c) "ex-serviceman" means a person who has served in any rank, whether, as a combatant or non-combatant, in the Armed Forces of the Union of India, including armed forces of former India states but excluding the Assam Rifles, Defence Security Corps, general Reserve Engineering Force, Lok Sahayak Sena and Territorial Army, for a continuous period of not less than six months after attestation and has been released, otherwise than by way of dismissal or discharge on account of misconduct or inefficiency, or has been transferred to reserve pending such release or has to serve for not more than six months for completing the period of service requisite for becoming entitled to be released or transferred to the reserve as aforesaid.

- (d) "family" means the ex-serviceman, his wife, sons below 18 years of age, unmarried daughters below 21 years of age and the non-earning parents of the ex-servicemen;
- (e) "financial assistance" means the financial assistance granted to the ex-servicemen and their dependants under these bye-laws;
- (f) "Fund" means the portion of the Special Fund for reconstruction and rehabilitation of ex-servicemen, which is set apart for expenditure on schemes of the Union territory and is managed by the Union territory Managing Committee.
- (g) "Managing Committee" means the Managing Committee constituted under Paragraph 8 of the Scheme;
- (h) "Scheme" means the scheme notified in Schedule B to the Government of India, Ministry of Defence, Notification No.S.R.O 234 dated 27<sup>th</sup> September 1966;
- (i) "Secretary" means the Secretary of the Rajya Sainik Board;
- (j) "Sub-Committee" means the sub-Committee constituted under bye-law 20 of these bye-laws; and
- (k) "Union territory" means the Union territory of Pondicherry.

#### **PART - III REGISTRATION**

## Register of ex-servicemen

- 3. (1) The Secretary shall maintain in the appropriate form a register in which the particulars of ex-serviceman shall be entered.
  - (2) An ex-serviceman shall be entitled for registration or re-registration with the Board on cancellation of his registration with the Rajya Sainik Board of any other State or Union territory if he satisfies any of the following conditions, namely:-
  - (a) if his permanent residence is entered at any place in the Union territory in his defence services discharge book; or
  - (b) if the wife of the ex-serviceman is a native of Union territory and he produces satisfactory evidence therefore; or

- (c) if any of his sons is employed in the Union territory of Pondicherry and the ex-serviceman is dependent on him; or
- (d) if the ex-serviceman himself is employed in any Government/Semi-Government/Public Organization in the Union territory and the ex-serviceman produces a certificate of employment from the employer; or
- (e) if the ex-serviceman is employed in a private organization and he produces a certificate of continuous residence for not less than six months in the Union territory from an officer of the Revenue Department, Pondicherry not below the rank of Deputy Tahsildar;
- (f) in the case of re-registration, if he produces the certificate of cancellation from the Rajya Sainik Board or Union territory with which he had his registration previously.
- (3) A record of registration with the Board shall be entered on the discharge certificate of the ex-serviceman by the Secretary.

## Posthumous registration

4. If an ex-serviceman died in harness or after his discharge, he may be registered posthumously on application from a member of his family subject to the condition that the ex-serviceman was the permanent resident of the Union territory or the applicant is a permanent resident of the Union territory and has been continuously residing in the Union territory for not less than 3 years on the date of such application.

## Appeal against refusal

5. Where the Secretary refuses to register any ex-serviceman under the foregoing bye-laws an appeal shall lie to the Managing Committee and the decision of the Managing Committee thereon shall be final.

#### **PART IV - FIANANCIAL ASSISTANCE**

### Scope of financial assistance

- 6. Subject to the other conditions laid down in these bye-laws in respect of any specific loan, grant etc., financial assistance in the form of loan, grant and stipends may be granted as provided in this part to the ex-serviceman and their dependants, and if the ex-serviceman is dead, to the members of his family provided that they satisfy the following conditions, namely:-
  - (i) the ex-serviceman is registered with the Board;

(ii) the total monthly income of the ex-serviceman's family does not exceed Rs.600/- per month: and

(Rs.600/- to be read as Rs.750/- as per amendment para 2 of Gazette (Part II) No. 31 dated 19 Aug 1982)

(Rs.750/- to be read as Rs.1,000/- as per para 2 of Gaz. No.36 dt. 03 Sep 1985)

(Rs.1,000/- to be read as Rs.1,500/- vide para 2 of Gaz. No.32 dt. 11.8.1987)

(Rs.1,500/- to be read as Rs.2,000/- vide para 2 of Gaz. No.45 dt.5.11.91)

(Rs.2,000/- to be read as Rs.2,500/- vide XIII ASF meeting dt.22.6.94)

(Rs.2,500-/ to be read as Rs.4,000/- vide para 8 (c) of XIV ASF meeting Minutes)

(Rs.4,000/- to be read as Rs.5,000/- in respect of marriage grant and children education grant only vide para 2 (a) of sub-Committee meeting Minutes of 2.9.99)

(iii) the applicant for the financial assistance produces an income certificate from an officer of the Revenue Department not below the rank of Deputy Tahsildar.

#### Short term loan to the employed ex-serviceman or the members of the family

- 7. The ex-serviceman and, if the ex-serviceman is dead, the members of his family may be granted short term loan not exceeding five hundred rupees subject to the following conditions, namely;
  - (i) the ex-serviceman or, the member of the family as the case may be, applying for the loan is employed in any government/quasi-Government/ Public or Private Organization; and
  - (ii) the application for the loan is accompanied by,
    - (a) a surety bond from permanent Government servant, or
    - (b) a security of immovable property by deposit of title deeds is offered by the applicant.
  - (iii) the loan shall be recoverable in twenty equal monthly installments of Rs.25/- each together with interest at the rate charged for Government loans.

(Bye-law No.7 substituted as follows vide para 3 of Gaz. No.36 dt 03 Sep 1985.

"No loan shall be granted to the Ex-serviceman and the members of his family by the board"

#### Stipend for educational purposes

- 8. The following stipends may be granted to the ex-serviceman and the dependants or, if the ex-serviceman not alive to the members of his family, namely:-
  - (i) a stipend of fifty rupees per month to the ex-serviceman who undergo training in the industrial Training Institute, Pondicherry or Karaikal;
  - (ii) a stipend of forty-five rupees per month to the dependants of the ex-servicemen, or as the case may be to the members of their families who undergo training in the industrial training Institute Pondicherry and Karaiklal;
  - (iii) a stipend of twenty rupees per month to the ex-servicemen and their dependants or, as the case may be, to the members of their families, who undergo Teachers' Training Course in Pondicherry;
  - (iv) a stipend of two hundred and fifty rupees per month to the Exservicemen who undergo training at Queen Mary's Technical School, Kirkee Pune or in any other training institute (This clause inserted vide para 3 of Gazette (part II) No.31 dated 19 Aug 1982)

(Rs.250/- to be read as Rs.600/- vide para 3 (a) of Gaz. No.45 dt. 5.11.91)

(v) a sum of Rs.500/- is to be paid to the wards of the ex-serviceman who undergo vocational courses such as B.Ed., Mechanical, Electrical, Fitter, Computer Programme etc., (This clause inserted vide para 3 (b) of Gaz. No.45 dt. 5.11.91)

Provided that the stipends mentioned above shall be granted in addition to any other stipend that the recipient may get from the institution concerned.

## Grant of Stipend subject to regular attendance

9. The grant of stipend under bye-law No.8 every month shall be subject to the furnishing of a certificate from the head of the institution, in which the beneficiaries is undergoing training, to the effect that he or she had been regular in her attendance in the previous month.

# Re-imbursement of fees paid for short term technical courses

10. The dependants of the ex-servicemen or, if the ex-serviceman is not alive, the members of his family may be granted re-imbursement of fees paid by them for undergoing studies in short term technical courses like typewriting, shorthand, accountancy, book-keeping etc., in recognized institutions on their producing the receipts given by such institutions for the fees paid by them for the courses.

Provided that the assistance granted under this bye-laws shall not be admissible for a period exceeding six months.

#### Re-imbursement of Tuition Fees.

- 11. (1) The children of the ex-serviceman may be granted re-imbursement of tuition fees paid by them at the following rates:-
  - (i) payment of actual tuition fees paid by the wards of the exervicemen studying in Engineering, Agricultural, Dental and Medical Colleges.

Provided that the students shall be studying in the Government Institutions located in the Union territory of Pondicherry for eligibility for reimbursement under this bye-law; and (This Clause (i) inserted vide para 4 (a) of Gaz. No.45 dt. 5.11.91)

- (ii) Post-matric courses Full tuition fees subject to the condition that the scholar is not above 25 years of age
- (iii) Pre-matric Courses -

(a) for unemployed ex-servicemen - Half of the Tuition

(amended to read as three fourth vide para 4 of Gaz. (part II) No. 31 dt. 19 Aug 1982)

(b) for employed ex-servicemen- One quarter of the Tuition fee

### Book and Uniform Allowances

12. (1) The dependants of ex-servicemen or, after death of the exserviceman, the members of his family, may be granted books allowance in lump sum for purchase of books for each course at the following rates, namely:-

(i) Higher Secondary Class - Rs.30/ (ii) Bachelors Degree Courses - Rs.75/ (iii) Post Graduate Courses - Rs.100/ (iv) Professional Degree Courses - Rs.150/-

- (vi) Spot Assistance of Rs.5,000/- to unemployed/economically needy exservicemen/widows due to severe injury in road accidents/mishaps other than natural calamities which are not covered under AGI or KSB. This will be based on prescription of specialist Doctor treating/who has treated the case alongwith the estimate/cost of treatment. (Inserted vide para 10 (c) of XV ASF meeting Minutes).
- (vii) Cash incentive of Rs.5,000/- be given for outstanding Academic Merit wards of ex-servicemen ie for first three positions in the college/university in any discipline in graduation/post graduation or for award of Ph. D., (Inserted vide para 10 (g) of XV ASF meeting Minutes)

#### **Funeral Grant**

14. On the death of the ex-serviceman, his widow or any other member of his family shall be granted a funeral grant of two hundred and fifty rupees.

#### Maintenance grant to indigent ex-servicemen or their widows.

15. (1) The ex-servicemen, who are in indigent circumstances or, the widows of ex-servicemen, who are in such circumstances may be granted maintenance allowance of thirty rupees from the fund; (Rs.30/- to be read as Rs.45/- vide para 6 of Gaz. (part II) No.31 dt.19 .8.82) (Rs.45/- to be read as Rs.50/- vide para 6 of Gaz. No.36 dt. 03 .9.85) (Rs.50/- to be read as Rs.75/- vide para 5 of Gaz. No.32 dt. 11.8.87) (Rs.75/- to be read as Rs.100/- vide para 8 (i) of Gaz. No.45 dt. 5.11.91)

(Rs. 100/- to be read as Rs 150/- vide para 4 of Gaz No 40 dt 5.10.93)

(Rs.150/- to be read as Rs.200/- for widows and Rs.300/- for XSM vide XIII ASF meeting dt. 22.6.94)

Provided that the ex-serviceman should have completed sixty years of age for eligibility for the grant under this bye-law.

Explanation: An ex-serviceman or a widow of an ex-serviceman shall be deemed to be in indigent circumstances, if he or she has no source of income.

(2) Any assistance under this bye-law shall be personal to the grantee terminable with his or her life time and any amount remaining undisbursed at the death of the grantee shall lapse into the Fund

15.B The widow of ex-serviceman may be issued two pair of cloths (2 Sarees and 2 blouses) free of cost once in year (Inserted vide para 7 of Gaz. No.32 dt. 11.8.87).

#### Relief during natural calamities

- 16. (1) An ex-serviceman, or if the ex-serviceman is not alive the members of his family who has sustained damages in cyclone, flood or fire may be granted a lump sum grant not exceeding one hundred and fifty rupees, or the actual amount of damage suffered by them, whichever is less, provided they produce a certificate from an officer of the Revenue Department not lower in rank than that of Deputy Tahsildar, as to the extent of the damage.
  - (2) The relief granted under this bye-law will be over and above the grant that may be given by the Government.

Provided that the amount of relief obtained from the Government together with the amount granted under this bye-law shall not exceed the actual amount of the damage sustained by the grantee.

## Special grants for ex-servicemen who are disabled

17. An ex-serviceman who is disabled with 50% or more disability, while he was in service will be given lump sum grant not exceeding three hundred rupees on his producing a certificate from any specialist in a Government Hospital as to the nature and extent of disability.

# Special grants for ex-servicemen who die in harness or who are disabled or missing

- 18. (1) If a person, who was in active service is killed in action or dies or is missing for reasons attributable to his service, his widow or, or wife, as the case may be, granted the following assistance, namely;
- (i) A marriage grant not exceeding five hundred rupees for the marriage of each daughter;

Provided that where the widow or the wife is also dead the grant may given to the daughter for whose marriage the assistance is given;

- (ii) A lump sum grant of three hundred rupees to open a petty shop or for purchasing of Milchy cow.
- (2) If a person while on active service is killed, disabled or missing in action in forward areas the families of such persons may be granted a lump sum relief of five hundred rupees.

(3) In respect grants applied for under this bye-law, the claimant shall produce a certificate from the Commanding Officer of the last Unit in which the ex-serviceman was serving last to the effect that he was killed, disabled or missing, for reasons attributable to his service.

### General conditions

19. Notwithstanding any other condition that may be prescribed under these bye-laws, except where the assistance is by way of lump sum grant for general relief and maintenance, the recipients of the grant shall, within three months from the date of receipt of the assistance, furnish to the Secretary an utilization certificate to the effect the grant was expended for the purposes for which it was granted, supported by relevant vouchers if the vouchers had not been already produced in pursuance of any specific conditions attached to the grant of the assistance:

Provided that the Secretary may at his discretion, for reasons to be recorded, in writing dispense with the production of vouchers alongwith the utilization certificate.

#### PART V - PROCEDURE AND SANCTION

# Constitution of Sub-Committee to scrutinize applications and approve assistance

20. There shall be a Sub-Committee to scrutinize applications and sanction loans or grants under these bye-laws with the following members, namely:-

(i) Chief Secretary to Government Pondicherry - Chairman

(ii) Inspector General of Police Pondicherry - Member

(iii) Collector, Pondicherry - -do-

(iv) Secretary (Welfare), Pondicherry - -do-

(v) Secretary of the Board - Member Secretary

## Meetings of the Committee

21. (1) The Sub-Committee shall meet once in every quarter or at such earlier frequency, as the business before the committee may warrant. The Secretary of the Board will convene the meeting on the orders of the Chairman of the committee.

- (2) Two-thirds of the members of the Sub-Committee the quorum for the meeting and when there is no quorum the meeting of the sub-committee will be adjourn to a date that may be fixed by the Chairman of the committee.
- (3) The decision of the Sub-Committee will be by vote of the members present and voting and when there is tie issue will be decided by a costing vote by the chairman of the Sub-Committee.

# Applications for the assistance to be presented to the Secretary

22. The applications for grant of financial assistance under these bye-laws shall be addressed to the Secretary, who shall after satisfying himself that the application is complete in all respects circulate the application in the form of a proposal to sanction the assistance to the members of the Sub-Committee for their approval.

## Processing of applications

- 23. (1) The proposals other than the proposals for sanctioning of grants/loans shall be submitted by the Secretary to the Sub-Committee by circulation and if the Sub-committee decides that the assistance may be granted, they may accord their sanction there for.
- (2) The Sub-Committee may, if it so decides demand any application to the secretary for further inquiry or for eliciting further information and resubmission thereafter.
- (3) Authority to pay various grants, where the quantum has already been fixed delegated to Director, Sainik Welfare and individual cases not referred to sub-Committee. Such expenditure be placed before Managing Committee for ratification.(Inserted vide para 6 (d) of XIV ASF meeting Minutes)

Provided that where the majority opinion is not in favour of sanctioning the assistance the proposal shall be placed before a meeting of the subcommittee.

#### Decisions of the Sub-Committee to be communicated

24. (1) All the decisions of the Sub-Committee approving the grant of assistance shall be communicated to the grantee by the Secretary in the form of sanctions.

### Appeal to the Managing Committee

25. An appeal shall lie to the Managing Committee against all decisions of the Sub-Committee refusing to sanction the assistance applied for and the decision of the Managing Committee thereon shall be final.

# Amount sanctioned to be drawn and disbursed by the Secretary

26. The Secretary shall draw the assistance sanctioned under these bye-laws and disburse the same to the grantee under proper acquittance.

### Relaxation

- 27. (1) The Managing Committee may, at its discretion, for reasons to be recorded in writing, relax any of the provisions of these bye-laws in individual cases.
- (2) In cases of urgency the Sub-committee may relax the provisions of these bye-laws:

Provided that such cases, in which relaxation has been given by the Sub-Committee, shall be submitted to the Managing Committee in its next meeting for ratification and where the Managing Committee declines to ratify the relaxation the assistance sanctioned shall be withdrawn:

Provided further that where an assistance is granted in anticipation of ratification by the Managing Committee the sanctioning thereof should be provisional and the grantee shall be required to execute a bond undertaking to refund the assistance received in the event of Managing Committee declining to ratify the relaxation given in his favour by the Sub-Committee.

### Assistance sanctioned to be reported to the Managing Committee

28. All financial assistance sanctioned under these bye-laws shall be reported by the Secretary to the Managing Committee in its meeting held next after the sanctioning of the assistance.

### Power of Review of Managing Committee

29. The Managing Committee may call for any paper relating to the sanctioning of the assistance under these bye-laws and review the same and pass orders confirming or reversing the decision of the sub-Committee and the decision of the Managing Committee shall be final.

### Spot Assistance

- 30. (1) Where the Secretary is satisfied that any ex-serviceman or a widow of an ex-serviceman is in need of immediate assistance he may, for reasons to be recorded in writing sanction a spot assistance not exceeding fifteen rupees. (amended for fifteen rupees to be read as "one hundred rupees in exceptional cases" vide para 8 of Gaz. No. 32 dt. 11.8.87)
- (2) As soon as may be, after the spot assistance under these bye-laws is sanctioned a report shall be made the Chairman of the Sub-Committee indicating the circumstances in which the spot assistance was granted.

### Interpretation

31. If any doubt arises as to the interpretation of these bye-laws it shall be referred to the Managing Committee and the decision of the Managing Committee shall be final.

# GOVERNMENT OF PONDICHERRY DEPARTMENT OF SAINIK WELFARE DRAFT DETAILS OF RIGHT TO INFORMATION ACT, 2005

#### SALIENT FEATURES OF THE RIGHT TO INFORMATION ACT. 2005

- 1. The short title of the legislation has been changed from `The Freedom of Information Act' to `Right to Information Act'.
- 2. Provide a very definite day for its commencement, i.e. 120 days from enactment.
- 3. It defines "appropriate Government" as meaning, in relation to a "Public Authority" established, constituted or owned or substantially financed by funds provided directly or indirectly or controlled:
  - (i) by the Central Government, the Central Government;
  - (ii) by the State Government, the State Government'.
- 4. It shall apply to "Public Authorities" which means any authority or body or institution of self-government established or constituted by or under the Constitution; by any law made by the appropriate Government or, any other body owned, controlled or substantially financed directly or indirectly by the appropriate Government, and includes non-government organizations, substantially financed by the Government.
- 5. The ambit covers the two Houses of Parliament, State Legislature, the Supreme Court/High Court/Subordinate Courts including their administrative offices, Constitutional Authorities like Election Commission, Comptroller & Auditor General, Union Public Service Commission etc. Only domestic and foreign private bodies working within the country have been excluded from the purview of the Act.
- 6. All citizens shall have the right to information, subject to the provisions of the Act.
- 7. It casts an obligation on Public Authorities to grant access to information and to publish certain categories of information within 120 days of the enactment. The responsibility about *suo-motu* disclosure /publication by public authorities has been considerably enlarged.
- 8. The Act lays down the machinery for the grant of access to information. The Public Authorities are required to designate Public Information Officers and Assistant Public Information Officers within 100 days of the enactment and whose responsibility it is to deal with requests for information and also to assist persons seeking information.
- 9. Provision has been made for transfer of a request by a public authority to another public authority wherein the subject matter/information is held by the latter.
- 10. A time limit of 30 days has been prescribed for compliance with requests for information under the Act, which, can be extended to 40 days where third-party interests are involved.

- 11. Fee to be reasonable. Also, no fee to be charged from persons who are below poverty line. Further, information to be provided free of charge where the response time-limit is not adhered to.
- 12. Certain categories of information have been exempted from disclosure under sections 8 and 9 of the Act. The categories, by way of illustration, include, information likely to affect security of the State strategic, scientific or economic interests of the State, detection and investigation of offences, public order, conduct of international relations and Cabinet papers. Trade or commercial secrets, information the disclosure of which would cause breach of privilege of Parliament or State Legislature and personnel information which has ;no relationship with public activity and could cause unwarranted invasion of the privacy of any person, are also exempted from disclosure. However, exemptions provided are not absolute and withholding of information must be balanced against disclosure in the public interest. Information to be released even if harm is shown to the public authority if the public benefit in knowing the information outweighs the harm that may be caused by disclosure.
- 13. Subject to 3 exception; the Act also contains a provision for reveal of information, which is otherwise, exempted from disclosure under section 8 on completion of the event.
- 14. The Act also incorporates the principle of severability.
- 15. Envisages creation of an independent non-judicial machinery, viz, Central Information Commission and State Information Commissions comprising a Chief Information Commissioner and Information Commissioners to decide 2<sup>nd</sup> stage appeals.
- 16. Legal frame work of exercise of power by the Commission defined in the Act.
- 17. The Act also provides a two-tier Appellate Forum. First appeal to departmental officer senior to the Public Information Officer. The second appeal to be made to Commission.
- 18. On a request for information being refused, the applicant can prefer an appeal to the prescribed authority within 30 days of the decision; the time limit for disposal of appeal being also 30 days extendable to 45 days.
- 19 Intelligence and security agencies specified in Schedule II to the Act have been exempted from being covered within the ambit of the Act. However, the exemption is not absolute; agencies shall have the obligation to provide information in matters relating to corruption and human rights violations.
- 20. The jurisdiction of subordinate courts has been barred expressly by section 23 of the Act.
- 21. The provisions of the proposed Act have been made overriding in character, so that the scheme is not subverted through the operation of other minor acts.

- 22. Monitoring and reporting-Act makes a provision to produce statistics to assess its implementation so that improvements could be effected.
- 23. Central Information Commission and State Information Commissions to monitor the implementation of the Act and prepare an Annual Report to be laid before Parliament/State Legislature.
- 24. Central Government to p prepare programmes for development of 'Information' regime.
- 25. FOI Act, 2002 to be repealed.
