post-mortem of cases in charges Central Prison, Puducherry, Special Sub-jail
Karaikal, Sub-jails Mahe & Yanam are directed to ensure that post-mortem
(near videography) and enquiry under the provisions of Cr.P.C. are carried out
and report of medical death occurring in the custody. Superintendant of Jails /
Sub-jails are directed to inform Competent Authorities through GHO of the
concerned Jails Station.
