NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to enhance the income ceiling limit of families belonging to Economically Weaker Sections (EWS) from Rs. 24,000/- to Rs. 75,000/- for availing grant of financial assistance/incentives, and for the said purpose, hereby makes the following amendment to the "Rules for Admission of students in Government Hostels for Backward Classes run by the Directorate of Social Welfare, Pondicherry" notified in G.O.Ms. No. 4/2009-Wel(SCW) dt. 02.03.2009 of the Chief Secretariat (Wel.) and published in the gazette of Pondicherry vide No. 8 dt. 10.03.2009 (hereinafter referred to as the said rules) namely:

AMENDMENT

In the said rules, in sub-rule (a) of rule 3, the following shall be substituted namely:-

"3. The annual income of the parents or guardian of the students for admission to these hostels should not exceed Rs. 75,000/-:

Provided that selection of boarders will be made in such a way that a student whose parent's / guardian's income is less, gets preference over the student whose parent's / guardian's income is more."
