NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to enhance the income ceiling limit of families belonging to Economically Weaker Sections (EWS) from Rs. 24,000/- to Rs. 75,000/- for availing grant of financial assistance/incentives, and for the said purpose, hereby makes the following amendment to the “Scheme for Free Supply of Tools to Poor Washermen and Barbers in the Union Territory of Pondicherry” notified in G.O.Ms. No. 38/2003-Wel(SW-V) dt. 19.09.2003 of the Chief Secretariat (Wel.) and published in the gazette of Pondicherry vide No. 118 dated 22.10.2003 (hereinafter referred to as the said rules) namely:

AMENDMENT

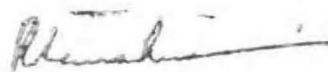
In the said rules, in sub-rule (a) of rule 5, the following shall be substituted namely:-

“5. Eligibility:

(a) The annual income of the applicant or his parent/guardian should not be more than Rs. 75,000/- per annum. The income of the parent/guardian will be taken into account only in cases where the applicant is dependent on the parent/guardian and he has no other source of income.”

3. This amendment shall be deemed to have come into force with effect from 08-09-2014.
