Applications are invited from eligible candidates for selection as Members for Child Welfare Committee and members for Juvenile Justice Board against the vacancies notified below for exercising powers and discharging the functions of the Committee / Board in relation to Children in Need of Care and Protection and children in conflict with law under Juvenile Justice (Care and Protection of Children) Act, 2015 and the Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017,

1. Qualification for Member of Child Welfare Committee (Rule 16) of the Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017) :

The members of the Committee shall be appointed by the Government on the recommendation of the Selection Committee under **rule 91** of these rules.

(1.1) Shall not be less than 35 years and not more than 65 years of age at the time of appointment

(1.2) shall have a minimum of 7 years experience in working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.

2. Qualification for Members of Juvenile Justice Board (Rule 4 of the Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017):

(2.1) The social worker members Shall not be less than 35 years and not more than sixty five years of age

(2.2) Shall have at least seven years of experience of working with children in the field of education, health, or welfare activities or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.

Note: The appointment will be subject to the provisions under Rule 92 (5) of the Puducherry Juvenile Justice (Care and Protection of Children) Rules, 2017.
