Applications are invited from eligible candidates for selection of Chairperson and four members for each district's Child Welfare Committee (Except CWC in Mahe Region) (One position is reserved for woman and one position is reserved for person who is expert in Child related issues) and two members for each district's Juvenile Justice Board (One position is reserved for woman), for exercising powers and discharging the functions of the Committee / Board in relation to Children in Need of Care and Protection under Juvenile Justice (Care and Protection of Children) Act, 2015.

- 1. Qualification for Chairperson / Member of Child Welfare Committee (Rule 15 (3) of Juvenile Justice (Care and Protection of Children) Model Rule 2016):
- (1.1) More than 35 years of age
- (1.2) shall have a minimum of 7 year's experience in working with children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law including a retired judicial officer.

**Note:** The appointment will be subject to the provisions under section 88 (5) of the Juvenile Justice (Care and Protection of Children) Act, 2015

- 2. Qualification for Members of Juvenile Justice Board (Rule 4 (3) of Juvenile Justice (Care and Protection of Children) Model Rule 2016):
- (2.1) More than 35 years of age
- (2.2) Shall have at least seven years of experience of working with children in the field of education, health, or welfare activities OR
- (2.2) should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.

**Note:** The appointment will be subject to the provisions under section 4 (4) of the Juvenile Justice (Care and Protection of Children) Model Rule 2016.
