NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to make the following rules further to amend the Puducherry Old Age Persons and Destitutes Pension Rules, 2011 notified in G.O.Ms.No.42/2011-Wel(SW-IV), dated 23.12.2011 of the Chief Secretariat(Welfare), Puducherry, namely:

RULES

1. **SHORT TITLE AND COMMENCEMENT:-** (i) These rules may be called the Puducherry Old Age Persons and Destitutes Pension(Amendment) Rules, 2013
(ii) They shall come into force with effect from 1st December 2013.
2. **AMENDMENT OF RULE 7:-** In the Puducherry Old Age Persons and Destitutes Pension Rules, 2011, (herein after referred as the said rules) in the rule 7, in sub-rule(2) for the symbol and figures "₹.1000/-" the symbol and figures "₹.1100/-" shall be substituted
3. **AMENDMENT OF FORMS .** - In the said rules in Form II (Order of sanction of Pension), in para 1, for the symbol, figures, brackets and words "₹.1000/- (Rupees one thousand only)" the symbol, figures, words and brackets "₹.1,100/- (Rupees One thousand and one hundred only)" shall be substituted.
