RULES FOR THE GRANT OF INCENTIVE TO THE FAMILY HAVING ONE GIRL AND PARENTS WHO HAVE UNDERGONE FAMILY PLANNING

- l. Short title, extent and commencement.— (i) These rules may be called the Rules for the Grant of Incentive to the Family having one Girl and the Parents who have undergone Family Planning.
- (ii) These rules shall extend to the whole of the Union Territory of Pondicherry.
- (iii) These rules shall come into force from the date of their publication in the official gazette.
- 2. Definitions.— In these rules, unless the context, otherwise requires,—
 - (i) "Director" means the Director of Women and Child Development in the Department of Women and Child Development, Government of Pondicherry;
 - (ii) "Family with one girl" means a family (Husband and Wife) having one girl child and which does not have a son or any other issues;
 - (iii) "Form" means a form appeared to these rules;
 - (iv) "Government" means the Administrator of the Union Territory of Pondicherry appointed by the President of India under article 239 of the Constitution of India:
 - (v) "Sterilisation" means either of the parents should have undergone Vasectomy or Tubectomy or any other family planning measures approved by the Government.
- 3. Objects.— The objective of this scheme is to create awareness among the parents about the desirability of having a girl child and to raise the status of a girl child in families. The scheme aims at small family norms and promoting the welfare of the girl children. The scheme is also aimed at preparing the parents to realise the value of girl children and treat them as an asset.

- 4. Eligibility.— (i) The age of the parents should not be necessary 21 years for father and 18 years for mother and shall not be not be above 45 years in respect of both as on the date of marriage.
- (ii) The annual income of the family from all sources should not exceed Rs. 60,000.
 - (iii) Parents should produce the birth certificate of the girl child.
- (iv) (a) Parents should produce certificate to the effect that either of the parents has undergone family planning in a Central/State Government Hospital/Clinic or any other approved institution recognised for the purpose.
 - (b) If the operation is done in a private hospital/nursing home, the certificate should be countersigned by a Medical Officer/Civil Surgeon of Government Hospital.
- (v) Parent should be citizen of India and either of the parents should be native of the Union Territory of Pondicherry by virtue of birth or by continuous residence of not less than 5 years.
- (vi) Parents should produce a certificate to the effect that they do have only one girl child and do not have any other issue.
- (vii) If the first child born happens to be a male and died subsequently, the next female child is eligible for assistance under the scheme subject to the satisfaction of other eligibility criteria.
 - (viii) Parents should produce their Marriage Certificate
- 5. Amount of assistance.— An amount of Rs. 14,762 will be deposited in fixed deposit in the Bank or in a suitable Post Office Scheme in the name of the girl child. The maturity value will be given to the girl child only when she attains the age of eighteen years. The mother of the child shall be the guardian of the minor's account. If the mother predeceases, the father shall be the guardian of the minor's account.

ŤΠ

In the event of both not alive, the legal guardian shall be the guardian of the minor's account. If premature death occurs to the girl child due to accident or otherwise prior to the completion of 18 years of deposit, the amount with accrued interest shall be given to the mother/father of the girl child as the case may be giving preference to mother if both are living.

- 6. Mode of applying.— (a) The application for grant of incentives under these rules shall be made to the Director in respect of Pondicherry region, the Child Development Project Officer in respect of Karaikal region and Social Welfare Organisers concerned in respect of outlying regions of Mahe and Yanam.
- (b) The application shall be made in Form-I accompanied by the following certificates, namely:-
 - (i) Income Certificate and Nativity Certificate in Form-II as detailed in rules 4 (ii) and 4 (v) above, obtained from an officer of the Revenue Department not below the rank of a Deputy Tahsildar.
 - (ii) A certificate in Form-III from a Member of Parliament or a Member of the Legislative Assembly or the Commissioner of Municipality/Commune Panchayat/ revenue official not below the rank of a Deputy Tahsildar, in whose jurisdiction, the applicant resides, to prove the conditions laid down in rule 4 (vi).
 - (iii) Certificate of Sterilisation as per conditions laid in rules 4 (a) and (b).
 - (iv) Certificate of age proof of the parent.
 - Certificate of birth of girl child.
 - (vi) Copy of the family ration card.
 - (vii) Photograph of the family.
 - (viii) Certificate of marriage of the parent.

- 7. Competent authority for selection of beneficiaries.— The Director, Department of Women and Child Development in Pondicherry region, the Child Development Project Officer in Karaikal region and the Social Welfare Organisers concerned in respect of Mahe and Yanam regions shall be the competent authority for selection of beneficiaries under these rules. They shall select the beneficiaries who fulfil the eligibility conditions prescribed in rule 4. lite - the world the water
- 8. Sanction of the assistance.—(i) The applicant who has fulfilled all the conditions under these rules and on sanction being accorded for the purpose by the Government the amount shall be deposited in fixed deposit and shall be made as per the seniority of the receipt of application subject to availability of funds under the scheme. The deposit made in the name of the girl child shall be in the joint account along with the Director for Pondicherry region, the Child Development Project Officer for Karaikal region or the Social Welfare Organisers concerned for Mahe and Yanam regions, and kept in the Treasuries of the respective regions till maturity. A copy of the deposit shall be given to the parent for evidential record.
- (ii) Separate registers and periodicals shall be maintained by the concerned officer. Necessary entries and other details shall be made available to the Director, Department of Women and Child Development to ensure proper implementation.
- (iii) The officers in the outlying regions who are authorised under these rules shall forward to the Directorate of Women and Child Development, an extract of the entries made during the month in the register maintained as required under sub-rule (ii) so as to enable to furnish quarterly and annual reports.


