

INCENTIVE TO WIDOW'S REMARRIAGE

1.	Objective	: To encourage widows to remarry a bachelor/widower to lead a normal life
2.	Amount of Assistance	: Rs. 20,000/- in the form of National Saving Certificate
3.	Eligibility	: a) The annual income of the widow shall not exceed Rs. 24,000/- per annum b) A native of the Union territory of Puducherry by birth or by continuous residence of not less than 5 years c) The bridegroom shall be a bachelor or a Widower.
4]	Certificates to be enclosed	: a) The application form should be submitted 30 days before the date of proposed marriage. b) Income and Residence certificate from the Revenue Department. c) Marriage invitation d) Age proof of the Individual e) Death certificate of the Bride's Husband
5]	Whom to apply	: The Deputy Director (Women Development), Department of Women & Child Development. Puducherry. The Child Development Project Officer, Karaikal. The Welfare Officer, Mahe/Yanam.
6]	Processing time	: The selection is periodical and depends on the availability of funds.

RULES FOR INCENTIVE FOR WIDOW'S REMARRIAGE

1. Short title and commencement: (1) These rules may be called Incentive for Widow's Remarriage Rules, (1981.)

(2) These rules shall come into operation from the date of their publication in the official gazette.

2. Application: These rules shall apply to provision of incentive by grant of financial assistance in the form of national savings certificates to widows who are remarried with a bachelor/widower so as to lead a normal life.

3. Eligibility: The applicants for grant of incentive under these rules shall fulfil the following conditions, namely:-

(1) The widow shall marry a bachelor or a widower.

(2) The applicant should produce a certificate from Member of Parliament/Member of Legislative Assembly or the Chairman/Commissioner of the Municipality/Commune Panchayat where she resides to the effect that she is a widow and her husband is a bachelor or widower as the case may be.

(3) No financial assistance is admissible under these rules, unless the applicant has resided in the Union Territory for a period exceeding three years at the time of making the application for financial assistance.

(4) The widow shall be in the age group of 18-35 years.

(5) The annual income of the widow should not exceed Rs. 500/-

(6) The applicant should ^{not have children who are earning members} furnish registration particulars of marriage.

4. Making of application: The application for the incentive for widow remarriage shall be submitted in Form-I by the intending applicant to the Director of Social Welfare, Pondicherry. The requisite application form shall be obtainable free of charge from the Office of the Director of Social Welfare, Pondicherry.

5. Amount of grant: The incentive shall be in the form of National Savings Certificate in the name of both husband and wife to the value of Rs. 3,000/- to be held in deposit for 7 years.

6. Documents to accompany the application: (1) Income and Residence Certificates to be obtained from the Revenue Department.

2. Certificate of age (Birth Certificate)

3. Certificate of age of the husband.

4. A Declaration signed by the applicant to the effect that she has no children who are earning members.

RULES FOR INCENTIVE FOR WIDOW'S REMARRIAGE

1. *Short title and commencement.* — (1) These rules may be called Incentive for Widow's Remarriage Rules, 1981.

(2) These rules shall come into operation from the date of their publication in the official gazette.

2. *Application.* — These rules shall apply to provision of incentive by grant of financial assistance in the form of national savings certificates to widows who are remarried with a bachelor/widower so as to lead a normal life.

3. *Eligibility.* — The applicants for grant of incentive under these rules shall fulfil the following conditions, namely : —

(1) The widow shall marry a bachelor or a widower.

(2) The applicant should produce a certificate from Member of Parliament/Member of Legislative Assembly or the Chairman/Commissioner of the Municipality/Commune Panchayat where she resides to the effect that she is a widow and her husband is a bachelor or widower as the case may be.

(3) No financial assistance is admissible under these rules, unless the applicant has resided in the Union territory for a period exceeding three years at the time of making the application for financial assistance.

(4) The widow shall be in the age group of 18-35 years.

(5) The annual income of the widow should not exceed Rs. 500

(6) The applicant should not have children who are earning members,

(7) The age limit for the husband shall be 25-45 ; and

(8) The applicant should furnish registration particulars of remarriage.

4. *Making of application.*— The application for the incentive for widow remarriage shall be submitted in Form-I by the intending applicant to the Director of Social Welfare, Pondicherry. The requisite application form shall be obtainable free of charge from the Office of the Director of Social Welfare, Pondicherry.

5. *Amount of grant* — The incentive shall be in the form of National Savings Certificate in the name of both husband and wife to the value of Rs. 3,000 to be held in deposit for 7 years.

6. *Documents to accompany the application.*— (1) Income and Residence Certificates to be obtained from the Revenue Department

(2) Certificate of age (Birth Certificate).

(3) Certificate of age of the husband.

(4) A Declaration signed by the applicant to the effect that she has no children who are earning members.

7. *Scrutiny of application.*— Each application shall be scrutinised by the Department of Social Welfare, Pondicherry, and forwarded to the Government for sanction.

8. *Sanction of the grant.*— On being satisfied that the applicant is eligible for the incentive under the rules, the same will be sanctioned by the Government.

9. *Disbursement of grant.*— The Director of Social Welfare, Pondicherry, shall distribute the incentive to the applicant on paper acknowledgment.

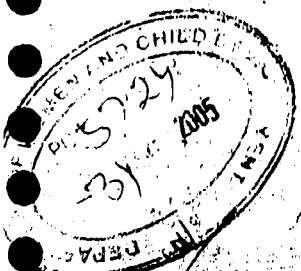

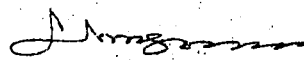
