ANNEXURE

"Scheme of Cash Award of Rs.1.00 lakh to the Government Special School (Differently Abled children) run by the Directorate of Social Welfare, Puducherry for achieving 100% results in the Public Examination (10th std)".

SHORT TITLE EXTENT AND COMMENCEMENT:

- The Scheme may be called "Scheme of Cash Award of Rs.1.00 lakh to the Government Special School run by the Social Welfare Department, Puducherry for achieving 100% result in the Public Examination(10th std)".
- ii. It shall come into force from the academic year 2012-13.

OBJECT:

To extend Cash Award of Rs. 1.00 lakh to the Government Special School run by the Directorate of Social Welfare, Puducherry for achieving 100% result in the Public Examination (10th std) for encouragement to the Teachers and Students.

SCOPE:

The Award shall be applicable to the Government Special Schools run by the Directorate of Social Welfare for achieving 100% result in Public Examination (10th Std) in the Union Territory of Pondicherry.

4. DEFINITIONS:

- (a) "Award" means the cash award instituted for the purpose of the Scheme.
- (b) "Special School" means the Government Special School for Differently Abled Children (Visually Challenged, Hearing Impaired) run by the Directorate of Social Welfare in the Union Territory of Puducherry.
- (c) "Government" means the Secretary to Government, Welfare Department, Puducherry.
- (d) "100%" means percentage of pass, secured by the Government Special School in the Public Examinations (Viz S.S.L.C.)

5. QUANTUM OF AWARDS:

Subject to fulfillment of eligibility conditions the quantum of award shall be as follow:

Name of the Pass Amount Examination percentage (Rs.)

S.S.L.C. 100% 1.00 lakh

6. UTILISATION OF CASH - AWARD / ELIGIBILITY:

The Cash Award shall be allotted for the School Development activities and setting up of infrastructure (viz) procurement of teaching and learning materials especially required for the development of the School. This procurement will be made on the recommendations of the Head of Institution concerned with the approval of the Director of Social Welfare. Based on the suggestions of the School level committee from among the items listed below.

- (i) Procurement of Library Books
- (ii) Teaching / Learning Materials
- (iii) Lab Articles
- (iv) Audio Visual equipment and Accessories
- (v) Computer and Computer Accessories
- (vi) Sports Materials
- (vii) Furniture
- (viii) Kitchen Utensils
- (ix) Repairs and Maintenance of school Building including electrical fittings, Furniture and other school equipment.

METHODOLOGY OF SELECTION:

The Principal / Officer In charge of the Government Special School shall prepare a list of the students who appeared to S.S.L.C Public Examination and submit the same to the Director of Social Welfare along with the mark sheets of the individual student who in turn will verify the percentage of result of the Government Special School of the particular academic year.

8. MODE OF DISBURSEMENT:

The Government Special School covered under this Scheme shall not be eligible to the Cash Award of Rs. 1.00 lakh (One Lakh) each to the Government Schools which achieve Public Examination Results in X and XII Std at 100% in urban and 90% in rural areas in the Union Territory of Puducherry – Notification G.O.Ms. No. 25 dated 20.02.2004 of the Chief Secretariat (Education), Puducherry. The Award will be given to the Principal / Officer in charge of School which achieved the excellence as required under the scheme on the "Children's Day" function every year.

9. INTERPRETATION AND CLARIFICATION:

In the implementation of the Scheme, if any doubt arises with regard to the interpretation of any of the provisions of the scheme or if any point requires clarification, the matter shall be referred to the Secretary to the Government. Welfare Department, whose decision shall be final.
